Quorum for the meetings of Executive Committee shall be 2/3 of its total strength. Notice for the meetings of Executive Committee should be given at least ~~three~~ ^{Seven} days in advance. However an emergency meeting can be called at a short notice.

(IX) FILING UP OF CASUAL VACANCIES

Casual vacancies should be filed by the Executive Committee through adoption/nomination from amongst the General Body members till next election.

SUB-COMMITTEE

To appoint and dedicate its powers to a sub-committee or to any member of the General Body for specific purposes.

SOURCE OF INCOMES WILL BE -

- (a) Membership Fee and contributions from the members of the society.
- (b) Voluntary donations by members of the society, individuals and various charitable organisations and other societies involved in social and community welfare work.
- (c) Funds available to the society shall be utilised with all sincerity and justice towards fulfilling the aims and objectives laid down by the society.

FINANCIAL YEAR

Financial year of the society shall be from 1st April to 31st March.

AUDIT OF ACCOUNTS

Yearly audit of accounts shall be carried out every year within three months after the close of year. - Contd...⁹ by the Chartered Accountant as appointed by Executive Committee.

FINANCIAL SECRETARY

- (a) To operate Bank Accounts of the society as authorised.
- (b) To maintain record of all accounts of the society.
- (c) To operate cash dealings of the society.
- (d) To receive raised and collect funds/Donations/subscriptions/dues etc.
- (e) To submit for audit to authorised - auditors all accounts registers, vouchers, receipts and other papers necessary for audit work.
- (f) To prepare and present the budget for the following year and the report of the income and expenditure of the preceding year in the annual meeting of the General Body.

(vii) POWERS OF THE EXECUTIVE COMMITTEE

- (i) All executive power shall be vested in the executive committee subject to the guidance of the General Body of the society.

- (iii) To fill up the vacancies caused by the absence of any member of the executive committee from its three consecutive meetings from amongst the members of the society.
- (iv) To authorise special expenditure for any specific purpose in anticipation of its being approved by the General Body.

- (vi) To appoint and delegate its powers to a sub-committee or to any member of the General Body for specific purposes.

VICE-PRESIDENT

To act in the capacity of the president in his absense or on delegation of powers by the President and to preside over the meetings of the Board of Management and the Executive Committee in the absense of the President.

GENERAL SECRETARY : He will be Chief Executive of the society.

- (a) To carry on day to day work of the society in conformity with the aims and objectives of the society and to execute the resolutions of Executive Committee and General Body.
- (b) To call the meetings of the society of his own accord or at the direction of the President.
- (c) To keep a regular written record of the proceedings of the meetings of the Executive Committee and the General Body.
- (d) To file, execute, defend, compromise, withdraw, refer to arbitration cases filed on behalf of or against the society in accordance with the decisions of the Executive Committee.
- (e) To suspend, appoint, dismiss, and employees on behalf of the society and to grant leave, allowance, increment to them subject to approval of Executive Committee.
- (f) To open and conduct account with banks, Post Office or other institution in the name of society.
- (g) To do all such other acts as may be deemed necessary for the achievement of the aims and objectives of the society.

ADDITIONAL SECRETARY

- (a) To assist the General Secretary in all his duties.
- (b) In absense of the General Secretary or on his delegation

or secret ballot as may be decided by Executive Committee.

(v) TERMS OF THE OFFICE OF THE EXECUTIVE COMMITTEE

The Executive committee shall be elected for a term of three years.

(vi) POWERS AND DUTIES OF THE OFFICE BEARING OF THE EXECUTIVE COMMITTEE

PATRONS :-

The honourable patrons are expected to place willingly their resources, knowledge experience, advice and financial assistance at the disposal of the Society.

PRESIDENT :-

- (a) To keep watch over the general working of the society.
- (b) To manage the society rightly and justly for the sole intention of achieving the aims and objectives of the society and to attempt for the betterment of the same.
- (c) To call meeting of the General Body and Executive Committee of the society through the General Secretary.
- (d) To preside over the meetings of the General Body and Executive Committee and exercise his vote in case of an equal division of votes.
- (e) To delegate all or any of his powers to the Vice-President or the General Secretary.

(IV) All members have rights to vote in the Annual General Body Meeting over the Agenda and elections of Executive Committee.

2. GENERAL BODY -

(i) DEFINITION OF GENERAL BODY

General Body shall comprise of all members of society. General members shall be represented in the Executive Committee from amongst themselves by a single transferrable vote.

(ii) POWERS, DUTIES AND FUNCTIONS OF THE GENERAL BODY

- (a) To elect office bearers and member of Executive Committee for a period of three years.
- (b) To do sincere efforts for achieving the aims and objectives of the society.
- (c) All powers as detailed in the objectives of these rules shall in general be vested in the General Body.
- (d) To consider and pass the Annual Budget of income and expenditure of the society.

To formulate to general policy of the society in conformity with its objectives.



(f) General Body will have a right to extend or curtail the rights and duties of the Executive Committee.

(iii) QUORUM & NOTICE OF MEETING AND PERIODICITY OF MEETINGS

Meeting of General Body must be held once in a year. Besides this annual meeting Executive Committee is free to call General Body meetings as and when it feels

4. SUBSCRIPTION FOR MEMBERSHIP -

- (a) Initial subscription shall be Rs. 10/- per sq. yards of the land under possession/ownership of the members.
 Admisional Fee Rs. 100/-
 (b) The annual subscription for membership of the society shall be Rs. 10/- per sq. yard of the total area under occupation/
 possession of the members.

5. CESSATION OF MEMBERSHIP -

Any member of the General Body or Executive Committee shall cease to be a member of the society and shall be removed or expelled by the executive committee on the following grounds :-

- (a) On his acting in contravention of the rules and regulations and contrary to the interest of the society;
- (b) On his being found serve personal interest and political aims;
- (c) On his being found involved in subversive, communal, distructive and other activities which are against the law of land and
- (d) Insanity, resignation, death and expiry of term
e.g. If any member fails to pay his/her timely subscription for continuing
3 months before ceases to be a member of the society.

1.6. RIGHTS AND PRIVILEGE OF MEMBERS -

As the society is purely a welfare society with the sole aim of serving community around them, no member is entitled to enjoy any special privilege from the society for the reason of being its member of Executive Committee or General Body. However, he may, in the course of performing the interest of society or in the course of doing his duty assigned to him by the society, avail of some facilities or enjoy any privilege subject to the approval/consent of Executive Committee.

- (I) All members have a right to know the affairs of society.
- (II) All members may ask for the details of receipt of funds and expenditure/distribution of funds etc.
- (III) All members have right to attend the Annual General Body

1.1. NAME OF THE SOCIETY -

1.2 & 1.3. MEMBERSHIP, ADMISSION & QUALIFICATION FOR MEMBERSHIP

i) GENERAL BODY MEMBERS

Any major person residing within the area/jurisdiction of society or having property there on who (a) sincerely believes in aims and objectives of the society and affirms to contribute monetarily or otherwise for the achievement of aims and objectives of the society and who (b) is acceptable to the Executive Committee may be taken as member of the society on (c) payment of Membership Subscription.

ii) EXECUTIVE COMMITTEE MEMBER

There will be 11 members of the Executive Committee consisting five office bearers and six executive members as elected directly by the General Body in its meetings, as defined in the succeeding clauses of these rules.

iii) PATRON

Eminent leaders from any walk of life deemed helpful for the society will be made patrons on their consent from time to time.

to Gram Panchayat issued 3 Notifications namely (a) 130 bighas and 15 biswas (b) 369 bighas and 01 biswas and (c) 1337 bighas and 01 biswas. On 27th June 1996 in which the land belong to our society was also included for the construction of staff quarters for the employees of Government of NCT. Being aggrieved by the step-motherly treatment meted out to our Society, we again approached the Hon'ble High Court of Delhi by filing a Writ Petition No. 1953/97 and obtained a status quo which prohibited the DDA and other authorities from carrying out any demolition.

Inspite of status quo, DDA had carried out demolitions in our society on 12th December, 2002, 29th September, 2003, May 2004, July 2004. It is also pertinent to mention that the name of our society features at Sl. No. 98 in the list of unauthorised colonies falling under "Development Area" of DDA of Najafgarh Zone and South Zone published by MCD. The name of our society also features at Sl. No. 392 in the list of unauthorised colonies published by DDA.

Our society was Registered in the year 1989 bearing Registration No. S/20381 dated 22nd September, 1989. Before this, the said society was known as "Sultan Gauri Plot Holders Welfare Association" and the same was unregistered and in existence since 1980.

In April 1994 DDA demolish the houses of our members taking them mistakenly belonging to Ruchi Vihar for which Seva Ram Sharma Inquiry Committee of unauthorised colony was formed. We represented our case before the said Mr. Seva Ram Sharma, IAS vide our letter dated 16.04.1994 and a delegation of our society members met the then Lt. Governor Mr. P.K. Dave.


On 1st June 1995, the land belonging to our society was notified with other land of Rangpuri alias Malikpur Kohi vide different notifications (a) 75 bighas and 5 biswas and (b) 306 bighas and 2 biswas and (c) 3264 bighas. Out of which Land and Building Department denotified 306 bighas and 2 biswas and 3264 bighas for construction of staff quarters for the employee of Govt. of NCT and Phase-IV of Vasant Kunj. Our society could obtained a status quo from High Court of Delhi on 16th January 1996 against our CWP No. 4789/95. Again on 27th June 1996 after leaving the land of VIP's and influential peoples and the land belonging
