

Sh. Jai Prakash, President, Resident Welfare Asson. has been submitting his request regularly through L&B Deptt. to denotify the land falling in Hazari Fark Colony of village Holambi Kalan. We have already sent our reply to L&B Deptt. vide our letter dt. 17-10-03 (Flag 'A').

In response of our reply dt. 17-10-03, Sh. Jai Prakash President visited the office on. 27-11-03 alongwith some other residents of the colony and requested to re-examine the case and on his request, I alongwith Dy. Dir. (N.L.) visited the site on 3-12-03 with my staff and it is found that the colony is well populated and adjacent to the 'Phirney' of village Holambi Kalan. The land of this colony falls in Khasra no.s 50//19, 20, 21 and 22 and does not effect the 100 Mtr.R/W road and does not dect the part of Integrated Frieght Complex of Narels Sub-City. During site visit, several residents gathered and requested to re-consider the matter as they have spent a lot of money in construction of their houses.

At site, the land of this coloy is being utilised as residential and 100% colony is built-up.

As per record, the land of khasra no. 50//21,22 i.e 50% Hazari Park colony of village Holambi Kalan has been notified u/s 4 and 6 vide notification no. F. 10(4)97/LAB/LA dt, 22-8-01 and 26-7-02 respectively for construction of 100 Mtr. RXW and Integrated Frieght Complex. At site the stone pillers of 100 Mtr. road are fixed and the colony is not coming in right of way.

- The notification of several colonies for demolition was served on our colony also. We had made representation to the concerned authorities and the Land & Development Dept. had also accepted in the survey that it is 100% built area for the purpose of residence (copy attached)
- The demolition was carried last year of several notified colonies and Hazari Park was among them. The people continued staying there with their broken homes and domestic effects, but the DDA showed possession of the colony which is not the correct situation.
- Our colony was also included among those which the DDA claimed that it needs for Feight Complex and 100 meter wide road. The fact of the matter is that very small part of our colony was coming under this project and we had made representations to that effect. We had also suggested that the DDA could acquire vacant land which is very much available adjecent to our colony so that a little shifting of the project towards the vacant land allow the survival of our residences. There was a positive remark by the DDA justifying our representation. (copy attached)
 - Our plea that now when there is re-consideration of Lal Dora and Lal Dora Extension areas in the whole exercise of finalisation of Master Plan, our colony must be considered among the colonies to be denotified, cancellation of the possession shown by DDA clearing it from the proposed project, to give us relief.

We would be greatful to you for taking kind view in the matter under humanitarian consideration, to let us live under our roofs built from the earnings of our sweat and blood and also our family members.
