Residents have registries from that time; it is situated on private land. Residents have been paying house tax since 1974 – 1975 & it was electrified in the year 1978-79 we have the water connection since 1989. Residents have already deposited the development charges for sewerage in the year 1996 with the M.C.D.

Moreover, this was the worst affected block doing the 1984 riots, where 16 peoples lost their lives & the Hon'ble sh. Butta Singh then Union Home Minister Visited our block & some relief was provided to the victims of riots.

It is also submitted that we had already submitted the required information / documents when we applied previously for the regularization on 15/12/2004 vide application No. 00047 & the name of our colony is also listed at Serial No.: - 268 in the list which was prepared by your good office.
