This is with reference to your letter No. DJE/SE/NW/II/2004/6803 dated 13.2.04 sent to this office regarding provision of water supply in the unauthorised colony named Prem Nagar, F & G Block, Kirari Road, Nangloi.

The matter has been examined and it is found that the above mentioned colony i.e. Prem Nagar, F & G Block (Sr.No. 661/1971) was earlier granted N.O.C. for electrification under the Delhi Administration policy vide letter No. TP/G/3937 dated 4.11.87. The total area of the colony is, however, not mentioned on the Layout plan but the total number of plot is mentioned as 306 in Block F & G. The Delhi Jal Board may take further action with respect to providing water supply in this colony as per their prevailing Policy. A copy of the L.O.P. available in record on which N.O.C. was granted on 4.11.87 is hereby enclosed for your reference.
