8. To file suit for the recovery of rent in the court of law and to do all acts, deeds and things which are necessary for the same to file the suit for possession and to receive the compensation for the Government.
9. To file suit for the ejectment for the said tenant/tenants from the said property in the court of law and to do all acts, deeds and things which are necessary for the same.
10. To appoint an advocate in the case/cases.
11. To apply and get the electrification, water supply and other service in the said property from the office of the appropriate authority/authorities.
12. To file affidavit or reply to any letter or notice issued by the appropriate authority regarding the said property.
13. To apply and get the compensation of the said property and to get the same registered in the office of sub-registrar or Appropriate Authority in India.
14. To execute a rectification deed/s of the said property and to do get the same registered in the office of sub-registrar or appropriate authority in India.
