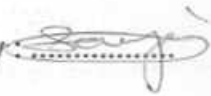

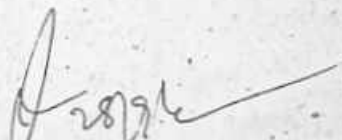

11. Suits by and against the Association :- The association may sue or be sued in the name of the President or the General Secretary.

12. Amendment to the Rules :- These rules shall be altered, extended or abridged only notice at an extra-ordinary general meeting specifically convened for the purpose; the notice where-of along with such report on the preposition as may be necessary, shall have been sent to every member of the association ten days previous to the special meeting convened by the managing committee for the consideration thereof, nor unless such preposition shall have been agreed to by the votes of 3/5th members present at a second special meeting concened by the managing committee at an interval of one month after the former meeting.

13. Dissolution (See 13 and 14 of Act):-

No person can hold more than one office at a time and therefore will be eligible to contest only for one office.

B. Source of Income:- The source of income of ther association shall be :-

a. Subscription and frees as laid down in the constitution.

b. Funds raised from time to time on specified counts.

c. Donations, If any.

d. Govt.aids/grant,if any.

9. Operation of the Bank Account :- These shall be authorised by the joint signature of Treasurer and either the President or the General Secretary.

10. Annual list of managing/Governing Body:- Once in every year, a list of the office bearers and members of the managing/Governing body of the Association shall be filled with the Rigister of Societies, Delhi as required under Section 4 of the Societies Registration Act 1860.

f. A notice of at least 14 days shall be given in writing for convening an ordinary meeting of the general body.

g. A meeting for want of quorum may be adjourned by the president/presiding officer and no quorum shall be necessary for such an adjourned Meeting.

h. The annual general meeting of the association shall be held once every year within three months of the completion of the official year, i.e. before the 30th of June. In this meeting besides transaction of other normal business, the election of the new managing committee shall also be held.

- (d) To prepare plans project and programs.

j. **Executive member:-** He will assist in day today work of the society/association as directed by president.

Note:- Not forming a part of the managing committee and working separately/independently of its control, the Auditor would nevertheless, be elected every year by the General Body of the association.

5. Functions & powers of governing body:-

Governing body shall be responsible for the management and administration of all affairs of the society/association and is also authorised to appoint any office bears. executive member to look after and particular activity, Governing body shall have also the following powers:-

- (a) To take necessary steps for the implementation of all the programs and policies drawn up by the general body.

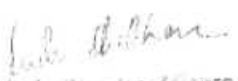

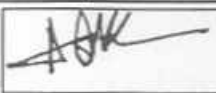

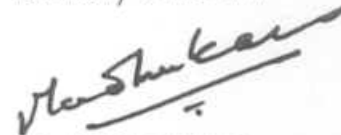
