# RULES AND REGULATIONS OF "SAMAJ KALYAN PARISHAD"

1. NAME The name of the society shall be "SAMAJ KALYAN PARISHAD"

2. MEMBERSHIP

Subject to the approval of governing body of the society any person may become a member of the society provided he/she believes in the aims and objects of the society.

3. SUBSCRIPTION The rate of subscription for all the members shall be & 12/- per year.

The governing body of the society may refuse any person for the membership, provided reasons for refusal shall be communicated to the person concerned.

The governing body of the society may expel any member from the society on the following grounds :-

- If the member fails to pay the yearly subscription continously for three months from the due date of paying the subscription.
- ii) If the member works against the aims and objects of the society.
- iii) If the member tenders his/her resignation.
  - iv) If the number fails to attend three meetings of general body & governing body.

The reasons of expulsion shall be communicated to every member. Every such expelled member shall have a right to appeal before the general body which my or may not be accepted.

- GENERAL BODY: There shall be a general body of the society consisting of all the members. The meeting of the general body shall be held after every one year with 1/3 quorum. No quorum shall be required in the udjourned meetings. An emergent meeting of the general body may also be summoned on the written request of 3/5 members. Following business shall be transacted in these meetings:
  - i; To prepare annual programmes and policies.
  - ii) To pass annual budget of the society.
  - iii) To discuss and to decide all such other matters and issues which are directly or indirectly related to the affairs of the society.
