Sir,

Kindly refer to letter No. 13037/113/74/UDI/II-B dated 10th February 1977 from the Ministry of Works & Housing, Government of India regarding regularisation of unauthorised colonies and the subsequent decisions whereby 549 colonies have been regularised till date.

The question regarding the regularisation of remaining colonies has been under the consideration of this Administration for sometime. The Lt. Governor of Delhi had constituted a Committee in May 1980 under the Chairmanship of Secretary, L&D to examine the question of regularisation of the remaining unauthorised colonies. Engineer-in-Chief, M.D., Commissioner (Planning), D.D.A., Director (CP), DDA, Commissioner (Planning), DDA, Commissioner (Town Planning), M.D. and Special Secretary, L&D, Delhi Administration were nominated as other members of this Committee, which submitted its report to the Lt. Governor on 28th August 1980.

The report submitted by the Committee and the various recommendations made by it, have been carefully examined by this Administration. The approval of Lt. Governor is hereby conveyed for regularisation of the following 48 colonies with immediate effect:

We regret to inform you that we have not yet received the reply to our letter No. SPRWA/22 dated 12-11-03 from your office. A photo-copy of the same is enclosed for your reference please. Hence this reminder:-

You are aware that the Suraj park Colony has been de-notified by Jt. Secy. (L&B), Delhi Administration vide no. F-12(108)/86/L&B/ part-26291 dated 13th July, 1987 which was published in Delhi Gazette on 30th July, 1987. A copy of which has been already sent to your office earlier. As such our Suraj Park Colony falls outside the development area of DDA. Hence this may please be handed over to MCD with immediate effect. It may be pointed out that recently a meeting was held between the Additional Secretary (U.C.), Urban Development, DDA & MCD officials through the Area Counselor Mr. Vijender Gupta dated 28-1-04. The Addl. Secretary (U.C.), Urban Development, directed the staff of DDA to verify the identity of de-notification in regard to this Suraj Park Colony and report the same at the earliest.

You are, therefore, requested to kindly issue No-objection Certificate to the Suraj Park RWA and secondly after being satisfied that the Suraj Park Colony falls outside the development area of DDA, proceed to handover the Suraj Park Colony to MCD with immediate effect.
