12. ELECTION AND QUORUM :-

The General body in its annual meeting will elect its office bearers and members after five years by secret ballot paper. However the same may be nominated unanimously with Two third majority in the interest of the Society.

The quorum of the General body and the Governing body shall be 2/3rd. the election proceeding of the society will be submitted in the office of the Registrar of Societies, Delhi, immediately after election held by the society.

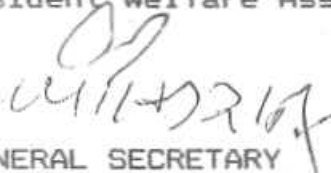

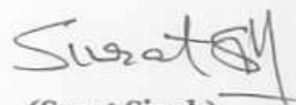

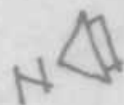
