11. OFFICE BEARERS AND THEIR DUTIES:-

1. PRESIDENT:-
- a. He shall preside over all the meetings of general body and governing body.

9. GENERAL BODY:- There shall be a general body of the society consisting of all the members. The meetings of the general body shall be held after every one year with 1/3 quorum. The notice period of general body shall be ten days. The following business shall be transacted in these meetings:-

- a. To prepare annual programmes and policies.
- b. To discuss and to decide all such other matters and issues which are directly or indirectly related to the affairs of the society.
- c. To pass <sup>annual</sup> budget of the society.
- d. To appoint a qualified auditor who will annually audit the accounts of the society's funds.
- e. To consider any business brought forward by the governing body.

10. GOVERNING BODY:- There shall be a governing body of the society to look after and to manage the day to day affairs of the society. It shall consist of minimum 7 and maximum 15 members including the office bearers. The meetings of the governing body shall be held after every three months with 1/3 quorum. No quorum is required in the adjourned meeting. An emergent meeting of the governing body may also be summoned on the written request of 3/5 members by 7 days notice of the meeting. the notice period of the governing body shall be 7 days. The following business shall be transacted in these meetings:-

- a. To take necessary steps for the implementation of all the programmes and policies drawn by the general body.
- b. To pass the necessary expenditure to meet the day to day requirements of the society.
- c. To take decisions on applications for ~~membership~~ <sup>Admit Card</sup> Delhi Rajni Khand Welfare Association, Not. 11, Extension, P.O. IGI OU, New Delhi-110068

d. If the member tenders his/her resignation.

e. If the member ~~fails~~ to attend three consecutive meetings of general body and governing body.

6. APPEALS:-

Every member shall have right to participate in the general body meeting and shall also be entitled to inspect the record of the association with prior approval of the governing body. Besides this he/she shall have also right to vote in the meetings of the association.
