(d) if so, the names of all such colonies alongwith the dates by which the decision would be taken for each case?

THE MINISTER OF WORKS AND HOUSING

(SHRI P.C. SETHI)

(a) Yes, Sir.

(b) The names of the colonies already approved by the Delhi Development Authority and Municipal Corporation of Delhi are indicated in Annexes I and II respectively. The criteria/considerations for regularisation of these colonies are laid down in this Ministry's letter dated 16.2.77 and 6.12.78 (Annexes III and IV).

(c) Yes, Sir.

(d) There are in all 611 unauthorised agglomerations including extensions of colonies and villages, in Delhi as per list in Annex V, which are to be approved in accordance with the Government's decision. Out of these, the colonies listed in Annexes-I and II have been approved by Delhi Development Authority and Municipal Corporation of Delhi. It is not feasible to lay down any time limit for regularisation of the remaining colonies.
