We will be highly grateful to you for this act of kindness.

(a) Electricity in the colony vide letter No SEDE/2H/4124/ dt 5 Jan 89.

(b) Water line installed vide No ZE/W IV/SHD-II/90/137 dt 21.9.90.

(c) A letter box installed in Gali No 12 by Postal Department, Gandhi Nagar. We hope that the matter may be taken into consideration at the earliest for the approval of the colony and laying of sewer line. We will be highly obliged to you.
