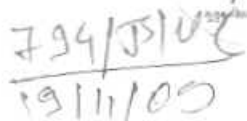

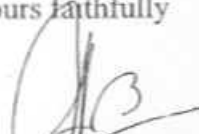
Earlier vide letter dt.17-7-2009, this office had provided the report of built up percentage pertaining to the year 2002 and also 2008-09. In the said report, the built up percentage of some colonies pertaining to the year 2002 could not be provided since the colonies could not be located on the aerial photographs as the RWA's had not given proper key plan.

Now, from the past few months the UD Deptt. has been sending the tentative boundaries of colonies marked on the copies of aerial photographs. So far 974 such colony boundaries have been received in this office and these have been referred to for finalizing the built up percentage of the left out colonies. Earlier, the DDA had provided the built up percentage of colonies (of year 2002) falling in their development area and the same figures are reproduced in the enclosed list with the colony names shaded. This may also be verified by the UD Deptt. before finalizing the same.

As far as the built up percentage of 'ELD' and 'Others' list is concerned, this deptt. is finalizing the same and will be provided early. In this regard, the UD Deptt. is requested to provide the boundaries of colonies pertaining to ELD' and 'Others' list so that the same can be finalised and handed over to the UD Deptt.
