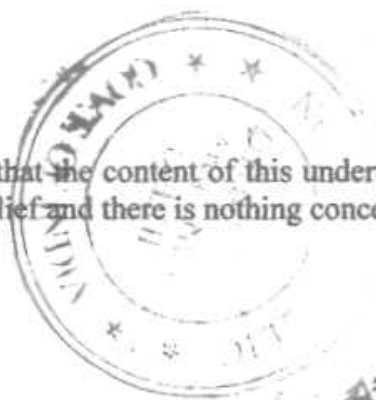

13. Any person having legal qualification can be appointed as a Legal Advisor of the Samiti.

Apart from the above, any person can become the Patron of the Samiti subject to the approval of the governing body.

All of the office bearers of the Samiti will perform their duties/responsibilities on honorary basis for the welfare and smooth running of the Samiti.

14. Annual list of governing body (Sec.4 of Act)

Once in every year a list of the office bearers and members of the Samiti shall be filed with the Registrar of Societies, Delhi as required under Section 4 of the Societies Registration Act, 1860.

15. Legal Proceedings (Section 6 of the Act)

The Samiti may sue or be sued in the name of the President or Secretary as per provision laid down under Section 6 of the Societies Registration Act, 1860, as applicable to the Union Territory of Delhi.

16. Any amendment in the Memorandum or Rules will be carried out in accordance with procedure laid down under Sec.12 & 12 A of Societies Registration Act, 1860.

17. Dissolution and Adjustment of affairs:

If the Samiti need to be dissolved, it shall be dissolved as per provision laid down under Sec.13 and 14 of the Societies Registration Act, 1860 as applicable to the U.T. of Delhi.

18. Application of the Act.

All the provisions under all the sections of the Societies Registration Act, 1860, as applicable to the U.T. of Delhi shall apply to the Samiti.

8. QUORUM AND NOTICE OF THE MEETING:

Quorum required for any meeting of the governing body shall be 1/3rd of members of the governing body.

Notice of the meeting will be circulated/conveyed as decides by the governing body.

9. Sources of income and utilisation of funds:

Samiti shall not have any main sources of income except of membership fees, voluntary donation/funds collected on the occasion of important functions etc. The amount will be invested/expended only for the development of the colony/Samiti.

10. Financial Year: Financial year of the Samiti shall be for the 12 months starting from 1st April to 31st March of every year.

11. Audit of accounts: The accounts of the Samiti will be audited by the Auditors of the Samiti in the financial year ending mentioned above.

12. Operation of Bank Account: Bank account will be opened in the name of the Samiti with any of the scheduled bank and the same will be operated by any two of the following ~~three~~ officials: *alongwith (c).*

- (a) President
- (b) General Secretary
- (c) Cashier

Office Secretary: He will look after the administration/regular affairs of the Samiti and will assist the General Secretary. In the absence of General Secty. he will be liable to perform the duties of G.Secty. on his behalf.

Joint Secretary: He will assist the General Secty. and Office Secretary in all respect.

Cashier: He will look after cash dealing of the Samiti under the guidelines/supervision of the President. He will make the payment only after prior approval of the President. Apart from this he will maintain the books of account, vouchers as per law of the Samiti.

Auditors : He will audit the accounts of the Samiti for the financial year ending 31st March of every year. He will prepare final accounts and will submit the report to the Samiti. He will also attend taxation matters, if any, before appropriate authorities on behalf of Samiti as and when required and authorised.

7. Powers/duties & function of the governing body:

- i) Governing body consisting office bearers of the Samiti as mentioned under clause 4 in Memorandum of Samiti will have the power and ensure smooth running of the Samiti in various aspects such as administration, functioning of the general meeting once in a quarter.
- ii) Passing resolution in regard to matters pertaining to welfare of the Colony.
- iii) Governing body will have the power to exercise for the functioning of the Samiti and development of the Colony.

The total strength of the governing body shall be 16 (Sixteen) including office bearers.

- new* The minimum strength shall be 16 and maximum shall be 21.
4. Election and its mode : Members of the governing body shall be elected in the meeting of the general body on the majority basis by secret Ballot papers. *new*

5. Terms of the office of the governing body : The terms of the governing body shall be only for two years and if needed, the general body can dissolve the governing body by 2/3rd majority at any time before which notice shall be given for the same.

6- Powers and duties of the governing body:

President : The president, elected by the General body is empowered to call for, adjoin and cancel any meeting of the Samiti. He can call for any documents/explanation/clarification in regard to the functioning of the Samiti whenever and wherever required. The decision taken by the President in the meeting of the general body shall be final and binding on all the members.

Vice-President : He will be assisting the President in the smooth functioning and running of affairs of the Samiti. In the absence of the President he will officiate as President but decision, if any, taken shall be come into force only after approval of the President.

General Secretary : General Secretary will look after day to day administration/affairs of the Samiti such as correspondence, maintaining proper records in regard to the meeting Agenda.

- v) Members can approach the Samiti at any time to solve their difficulties/grievances in regard to welfare of the Colony i.e. Kirari Extension.
- vi) Members have to attend the meeting of the Samiti regularly^{as} and when convened.

2. General Body: Any residents of Kirari Extension shall be admitted in the General body provided if the ages more than 18 yrs. and paying membership contribution as declared under sr.no.4 above.

General body shall empower to rise any question in the meeting regarding welfare of the Colony/Samiti and can take decision on the majority basis after approval of the governing body. Regarding audit of accounts etc. may be enquired.

Quorum : $\frac{1}{4}$ th of the General body will be acclaimed quorum of the General body. Any Resolution passed in the above mentioned quorum will be valid.

Notice of Meeting: Notice of general body meeting/periodically meeting will be circulated/conveyed as decided^{by} the governing body but it would certainly be declared before 24 hours of the meeting.

General body are empowered to dissolve the Executive by voting of $\frac{2}{3}$ rd majority.

3. Governing body: As declared in Memorandum of Samiti under Clause 4 & 5 are responsible for execution/activities of the Samiti and are liable for welfare of the Samiti.

RULES AND REGULATIONS OF SAMITI

1. NAME OF THE SAMITI: The name of the Samiti shall be

AGAR NAGAR VIKAS SAMITI C & D BLOCK

2. Membership Defined: Any residents of C-28, Agar Nagar P.N.3 shall become a member if he/she wishes so.

3. Admission and qualification for membership:

Plot owners otherwise residing in C & D BLOCK in a rental place for more than two years shall be admitted as a member of the Samiti provided if the ages more than 18 Yrs.

4. Subscription: Person who has become member of the Samiti shall pay Rs.10/- and Rs.5/- towards Annual and monthly subscription respectively in January of every year and within 10th day of every month. The subscription amount may be enhanced as and when the time demands.

5. Cessation of membership: Any member not abiding the rules & regulations of the Samiti and is irregular in paying the subscription for a continuous period of two months shall be ceased to be a member of the Samiti provided the governing body decides so or otherwise.

6. Rights & privilege of membership:

- i) Members shall have to follow rules and regulations of the Samiti to the best of his conscious.
- ii) Members shall have to pay Annual/monthly subscription without any demand and reminder.
- iii) Members have to abide by the decision of the governing body taken from time to time.
- iv) Members have to co-operate fully with the Samiti and ensure its smooth running working.
