13. FINANCIAL YEAR.

The financial year of the society shall be the financial year ending on 31st March every year.

14. SOURCE OF INCOME AND UTILIZATIONS.

Subscription, donations, grants-in-aid and gifts from the member society, All the income of the society shall be source of the income of the society, All the income of the society shall be utilized towards the aims and objects of the society.
