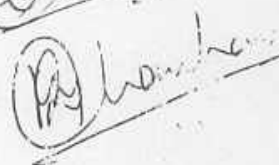

14.a) REGISTER OF MEMBERS :

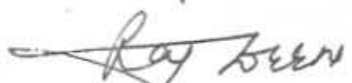

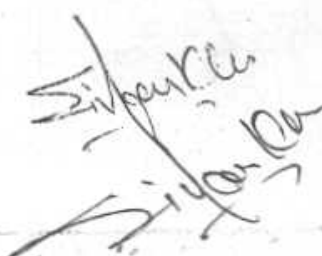

- f) To accept donation, charities, loan grants properties of departments in the interest of promotion of aims and objectives of the society.

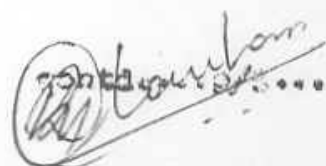

The governing body shall have the power to expell a member from the society on the following terms and conditions :-

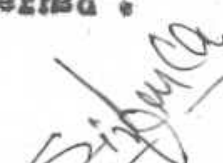
- a) By no confidence motion passed by 2/3rd majority of votes in the general body meeting.

- f) He/she has not attended three consecutive meetings of the general body without any intimation.

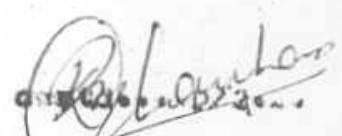

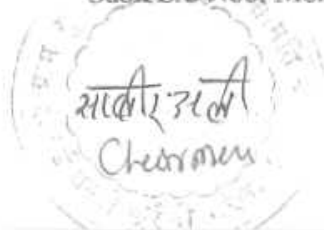

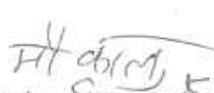
