

## **2. Duties of the President**

- a) He shall preside over all the annual general meetings, General Body, and Extra Ordinary meetings of the society.
- b) He shall exercise additional one vote in the event of a tie in voting.
- c) He shall advise the offices of the society and heads of the institutions/units under the society for efficient running of the society.
- d) He shall supervise and assist the office bearers and members of General Body of the Society, for the smooth functioning of the Society.
- e) He shall have power to act in between the meetings to be ratified at the next regular meeting.
- f) If the President does not carry out his duties in a responsible manner, the General Secretary can call for a meeting of the General Body of the Society. The Vice President shall preside over the meeting. The General Secretary can move a no confidence motion against the President. If this motion is passed by 51% of the membership of the General Body of the Society, the President can be removed from the post or may be allowed to continue in his post after imposition of appropriate fine as decided by the General Body. The entire proceedings must be clearly and accurately recorded.

## **3. Duties of the Vice President**

- a) He shall preside over the meetings in the absence of the President.
- b) He shall exercise the casting vote if he is presiding over the meeting as President.

#### 13. EXTRA ORDINARY MEETINGS

The President or Secretary can call for an extra ordinary meeting of the society or Governing Body on the requisition of 2/3rd members in writing. However, the President shall also have the power to call for an extra ordinary meeting.

#### 14. NOTICE OF MEETINGS

Clear 14 days notice shall be given to members of the society for AGM meeting. 7 days notice shall be given for meetings of the Governing Body, along with agenda, place and time of the meeting. For the extra ordinary meeting, 24 hours notice shall be given.

- d) The Governing Body shall open and operate bank accounts anywhere in India and operate through appointed/authorized signatories.
- e) To raise funds for the society through donations, borrowings etc. and to receive gifts/donations in cash/ kind, immovable properties with or without conditions.
- f) To invest funds of the society in legally approved investments.
- g) To procure, buy, equipment/appliances and things as may be necessary for the proper/efficient functioning of the society & attaining the aims and objects of the society through its programmes.
- h) To appoint any legal consultants for any other purpose on remuneration or honorary basis.
- i) To give grant to assistance to such eligible and needy persons on such terms and conditions as may be decided from time to time.
- j) To appoint committees, sub-committees to manage the affairs of any unit of the society.
- k) To do such other lawful duties and functions as may be necessary for the advancement of the aims and objects of the society.

#### 11. ELECTIONS

The elections of the Society members, members of the Governing Body or the office bearers, shall be conducted through secret ballot or show of hands or by nomination.

#### 12. QUORUM

The quorum of the Governing Body shall be four members present. If the quorum is not present, it shall stand adjourned for 30 minutes.

## 5. QUORUM

The quorum for the General Body shall be one third of the membership present. If the quorum is not present, then the meeting shall be adjourned for 30 minutes. At the adjourned meeting the members present shall form the quorum.


## 6. GOVERNING BODY

- 1) The management of the affairs of the society shall be vested in the Governing Body.
- 2) The term of the member of Governing Body shall be 3 years and eligible for re-election/nomination for another term. After which they have to step down for one year compulsorily to become eligible for election/nomination.
- 3) The Governing Body shall have not less than 7 members and not more than 15 members.

## 10. POWERS/DUTIES/FUNCTIONS OF THE BOARD OF MANAGEMENT

The Governing Body shall act between the two annual general meetings with powers vested by General Body and powers given below :

- a) The Board of Management shall be the trustees of the society in whom shall be vested all the properties both movable and immovable.
- b) The Governing Body shall meet 1st & 10th day of each month.
- c) The Governing Body shall be the appointing authority of all the staff in the society and its institutions, centres etc. It shall frame job description for all staff. It shall have power to promote, dismiss, discharge any staff on its own decision or on the recommendation of any committee appointed for such purpose.

## 5. RIGHTS & PRIVILEGES OF MEMBERS

Every member admitted shall have the right to receive notice of meetings and participate in the meeting with one vote.

## 6. GENERAL BODY

The General Body of the society is the body comprising of desirous persons forming the Society or members so admitted thereafter.

## 7. POWERS/DUTIES/FUNCTIONS OF THE GENERAL BODY

- a) The General Body shall meet at its Annual General Body twice in a year within 6 months from the date of closing of the financial year.
- b) The General Body shall lay down the general policies for the furtherance of the aims and objects of the society.
- c) The main agenda for the Annual General meeting shall be:
  - i) confirmation of the previous minutes
  - ii) adoption of the Annual Report of the Society presented by the Secretary
  - iii) adoption of the annual audit report with audited statement of accounts
  - iv) adoption of Annual Budget of the society
  - v) appointment of statutory auditor, legal consultants
  - vi) admission of new members to the society
  - vii) election of Governing Body members and Office Bearers.

- c) Every member shall be committed to the objects and purposes of the Society and shall agree to the Memorandum of Association and Rules and Regulations of the Society in writing.
  - f) Members shall pay in annual subscription as may, from time to time, be decided by the Governing Body.

#### B. Terms of Membership

- a) The term of members admitted shall be of 3 years and eligible for renomination or re-election for another term of 3 years after which to step down compulsorily for one year before he can be nominated or elected.
- b) The membership of the member shall cease on following grounds
  - i) His death
  - ii) His resignation
  - iii) His not agreeing to the Memorandum of Association & Rules and Regulations of the Society.
  - iv) Being adjudged insolvent or of unsound mind.
  - v) Being convicted by a court of law in a criminal case.
  - vi) Being absent from two consecutive Annual General meetings of the Society without apology in writing, and confirmation obtained from the secretary of the Society.
  - vii) On being found acting or engaged in any acts which are prejudicial to the interest of the Society as decided by a majority of the members present at the Annual General Meeting or Special Meeting.
  - viii) Membership fee, if any, is in arrear for two years.
