The Vice President shall preside over the meeting. The General Secretary can move a no confidence motion against the President. If this motion is passed by 51% of the membership of the General Body of the Society, the President can be removed from the post of may be allowed to continue in his post after imposition of appropriate fine as decided by the General Body. The entire proceedings must be clearly and accurately recorded.

3. Duties of the Vice President

- d) The Governing Body shall open and operate bank accounts anywhere in India and operate through appointed/authorized signatories.
 - e) To raise funds for the society through donations, borrowings etc. and to receive gifts/donations in cash/kind, immovable properties with or without conditions.
 - f) To invest funds of the society in legally approved investments.
 - g) To procure, buy, equipment/appliances and things as may be necessary for the proper/efficient functioning of the society & attaining the aims and objects of the society through its programmes.
 - h) To appoint any legal consultants for any other purpose on remuneration or honorary basis.
 - i) To give grant to assistance to such eligible and needy persons on such terms and conditions as may be decided from time to time.
 - j) To appoint committees, sub-committees to manage the affairs of any unit of the society.
 - k) To do such other lawful duties and functions as may be necessary for the advancement of the aims and objects of the society.

11. ELECTIONS

The elections of the Society members, members of the Governing Body or the office bearers, shall be conducted through secret ballot or show of hands or by nomination.

12. QUORUM

The quorum of the Governing Body shall be four members present. If the quorum is not present, it shall stand adjourned for 30 minutes.

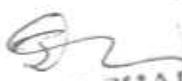
9. GOVERNING BODY

- 1) The management of the affairs of the society shall be vested in the Governing Body.
- 2) The term of the member of Governing Body shall be 3 years and eligible for re-election/nomination for another term. After which vvvvvvvvvv to step down for one year compulsorily to become eligible for election/nomination.
- 3) The Governing Body shall have not less than 7 members and not more than 15 members.

10. POWERS/DUTIES/FUNCTIONS OF THE BOARD OF MANAGEMENT

The Governing Body shall act between the two annual general meetings with powers vested by General Body and powers gives below :

- a) The Board of Management shall be the trustees of the society in whom shall be vested all the properties both movable and immovable.
- b) The Governing Body shall meet 1st & 10th day of the each month.

It shall have power to promote, dismiss, discharge any staff on its own decision or on the recommendation of any committee appointed for such purpose.

5. RIGHTS & PRIVILEGES OF MEMBERS

6. GENERAL BODY

The General Body of the society is the body comprising of desirous persons forming the Society or members so admitted thereafter.

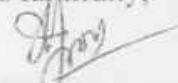

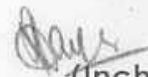
