Under the existing orders electrification of only those unauthorised colonies/ areas is undertaken which had come into existence before June 1977 and have since been regularised by MCD or DDA. Electrification of the enclosed leftout pockets of such regularised colonies is also permitted. The Delhi Administration vide its letter no. F.1/32/77-LSG/EW(II) Vol.III/7801 dated 3 December, 1986 has now permitted the electrification also of the unauthorised colonies (including unauthorised extensions of rural/urban villages) which had come into existence upto 1 January 1981. The procedure and commercial arrangements for electrification of the new areas thus becoming entitled will be the same as has been followed so far for electrification of regularised colonies; the procedure for grant of individual electric connections will also continue to be the same.

2. Electrification of unauthorised colonies/ areas will be undertaken on the basis of certification of entitlement by Town Planner, MCD.
