





**GENERAL SECRETARY:-**



- d. To take up effective but reasonable and lawful step for eradication of social evils such as dowry system, use of intoxicated drugs etc.
- e. To encourage co-operative spirit, equality and removal of untouchability.
- f. To carry on community development programmes for the upliftment of the economically weaker sections of the Society


