



18. Amendment :

(Alteration, extension or abridgement) of purposes' ( aims and objects) or change of the name, section 12 and 12-A of the S.R. Act of Delhi. The amendment in the Memorandum shall be made under this section.

19. Legal proceedings (section 6 of the Act) :

The society may sue or be sued in the name of the President as per provisions laid down section 6 of S. R. Act, 1860, as applicable to the Union Territory of Delhi.

20. Annual list of Governing Body :

Once in every year a list of the office bearers of the governing body shall be filled with the registrar of the society, Delhi as required under section 4 of the society registration Act of 1860, as applicable to the Union Territory of Delhi.

21. Dissolution :

If the society needs to be dissolved it shall be dissolved as per provisions laid down under section 13 and 14 S.R. Delhi Act of 1860, as applicable to the Union Territory of Delhi.

General Secretary :

The powers and duties of General Secretary shall be as under :

- a) To sign on behalf of the society and to conduct its correspondence and to record the proceedings of such meetings.
- b) To summon and attend the meeting of the general body.
- c) To call ordinary general meeting, if desired or written request of atleast twenty members.

Secretary :

In the absence of the General Secretary the Secretary shall enjoy all powers which are entrusted to General Secretary.

Treasurer/cashier :

The Treasurer keep accounts of all receipts and expenditures of the society and to furnish necessary information to the governing body. He will keep Rs. 500/- with him and the balance amount will have to be deposited in the Bank/Post office etc.

15. Audit :

The accounts of the society shall be audited at least once in a year by an auditor appointed by the Governing Body.

16. Financial year :

The financial year of the society shall start from 1st April to 31st March every year.

17. Terure :

The terms of Governing Body shall be two years.

**12. Functions of the Governing Body:**

- a) To arrange, finance, if required from others Bank's, institution or individuals on reasonable terms and conditions and the governing body as a whole liable for its return.
- b) The governing body shall make plan for the further programmes of the society.
- c) To appoint, terminate and fix duties of any staff.
- d) The governing body shall meet atleast once in a month.
- e) To publish literature, to propagate the system and to approach the public for the uplift the status of the society.
- f) To accept donations, charities, loans, property etc. from public, other association, agencies, Govt. Dept. for the promotion of the aims and objects of the society.

**13. Management of funds :**

All the income of the society shall be deposited in the Bank.

**14. Powers and duties of the office bearers :**

**9. Sources of Income :**

**10.**

The governing body's strength shall not less than 7 and not more than 17. The members of the Governing Body shall hold the office for two years. The meeting of the governing body shall be held as and when necessary, for which 15 days clear notice will be required and the quorum shall be 2/3rd.

**11. Election and Quorum :**

The General Body in its annual meeting will elect its president and all the office bearers and members in the month of March after two years by secret ballot papers and Quorum of the General body and Governing body 2/3rd.
