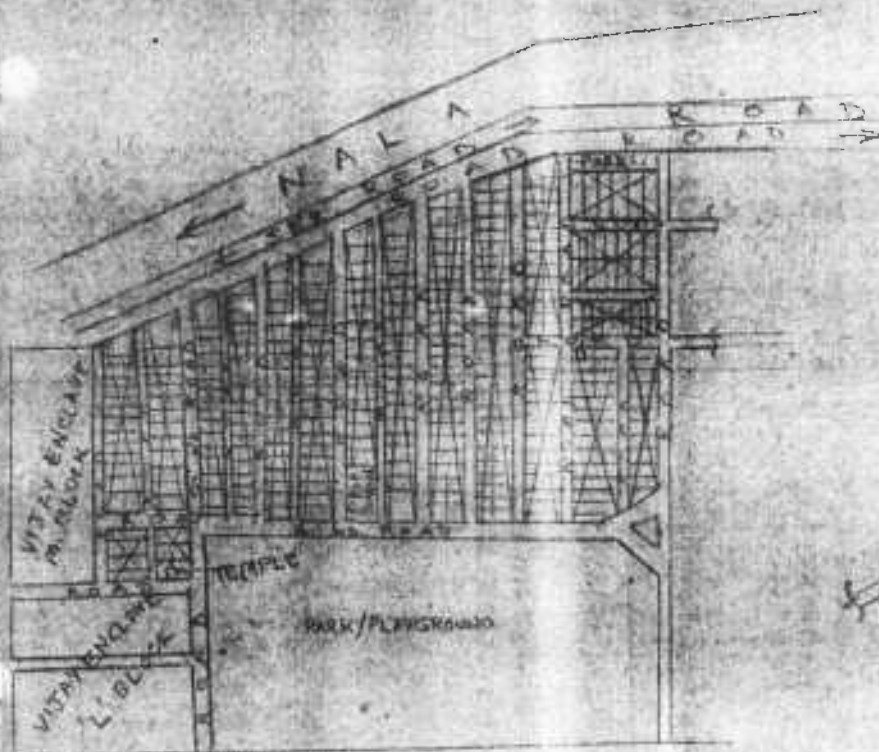
LAY OUT PLAN OF TAMILAR ENCLAVE AT PALAM DABRI ROAD NEW DELHI

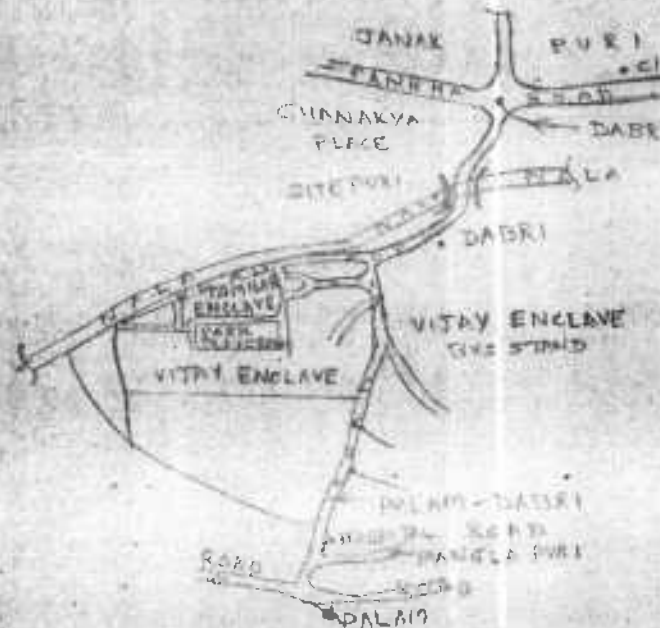
