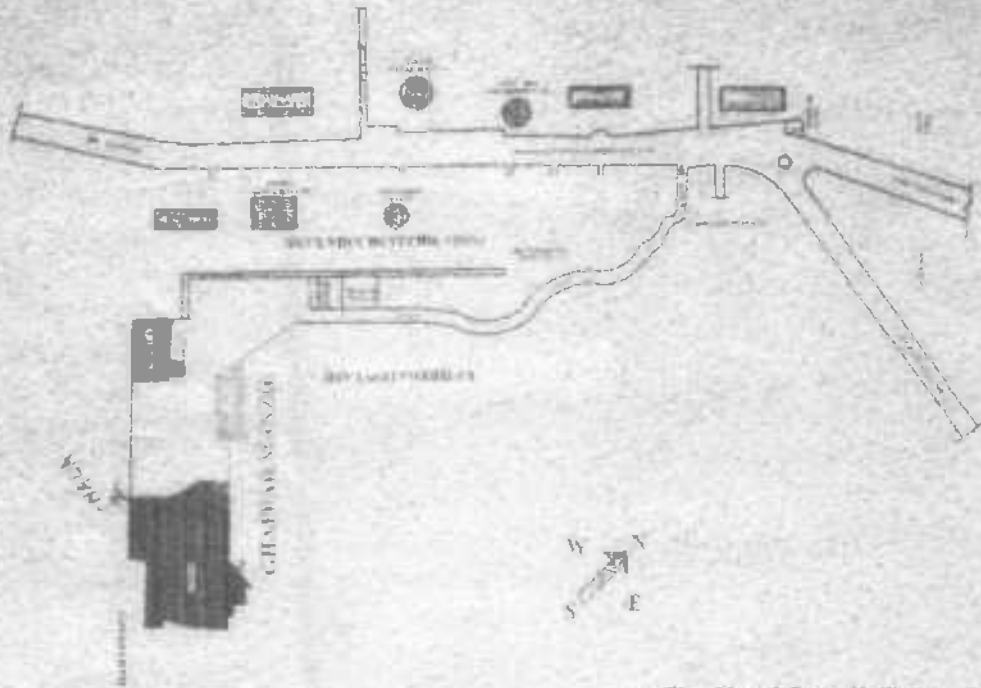

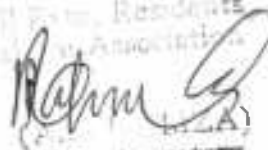

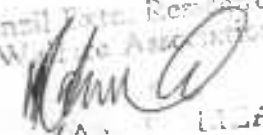

## The Executive Body

To sanction an expenditure as per need and the same shall be put for approval of the Executive Committee in the next meeting.

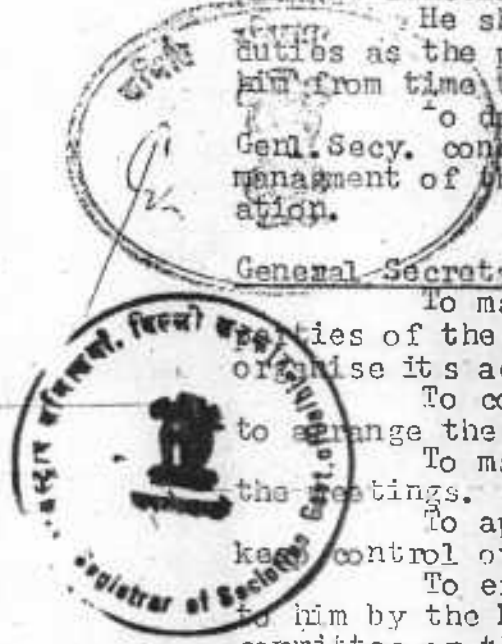
#### Joint Secretary:
