#### PRELIMINARY:

- The name of the Society shall be "CARIAPPA MARG RESIDENT'S WELFARE ASSOCIATION".
- 5) The objects of the society are as set out in the Memorandum of Association and may be altered, extended by the Governing Body in accordance with the provisions contained to that effect in Sec. 12 and 12 A of the Societies Registration Act of 1860.

#### 2 MEMBERSHIP:

- a) The Membership of the Society shall be open to Owners of the properties and all other authorised occupants of the property situated at 4834/24, Cariappa Marg, New Delhi.
- b) Any member qualified to be an Ordinary Member of the Society shall apply to the Society about his/her desire to become a member together with the subscription.
