Reference :- Public information, published in Dainik News papers, Nav Bharat Times, dated 4/11/07 and in Hindustan Times dated 9/12/07, respectively, through Sh. Raj Kumar Chauhan, Hon'ble Minister for Urban Development, Delhi Government and other Senior Authorities of Delhi state.

Respected Hon'ble Sir,

Kindly find enclosed herewith the desired information as called for, vide your letter under reference, on the above subject. It is also submitted that the Applications on the above subject with ample proofs with detailed documents & map etc. of the colony, as desired, have already been submitted twice, to the government of N.C.T. ie. on dated 8/09/04 and on dated 31/12/04, respectively.

But arbitrarily, the D.D.A. Officers, during the last, have threatend us and ^{entered}entired in the colony for demolition of the sturctures of the colony, against the policy and Guide lines of regularisation of unauthorised colonies, illegally & with an ultior ^{or} motive.

Being agrieved this association compelled to take shelter of LAW and thus, filed a writ petition No. 12527 of 2006 (Dated 3.08.06) in Delhi High Court accordingly, against the Authorities of D.D.A./ Govt. of N.C.T. of Delhi/Union of India, for not arising any demolition proceeding furthur, in the aforesaid colony, till the decision of regularisation of colonies by the Competent Authorities of Delhi/Delhi High Court. The photo copy of stay order of Delhi High Court, on the above writ petition, is also being annexed for ready reference.

④- Further, this colony is existed in the Area of Pansali Village, since 1988, absolutely on private land, having reserved the rights through Sale Deeds/ G.P.A.s, Individually and also thickly populated with other Aminities eg. Pacca Roads, Water Suply (By Tankers of DJB) & Pmt. Eelctirc Supply (By NDPL) & 5 Children Schools etc. More over 2 Big Bazars on the ground of "Chhat Puja Sthal" of the colony on every sunday & Thirsday of each month are being laid down for the last many years and also a Religious Mela on "Peer Baba Mazar" on every thursday of each month is celebrated since so many years.

⑤- It is also very important to note that the land/area as required for Aminities, as cited at Sl.No. 31st, of check list of unauthorised colonies, enclosed, may be achieved from the vacant land of Gram Panchyat/ D.D.A. land, which is lying open in the vicinity of Kailash Vihar Colony, which is more than suficiant and thus, this col. No. 31st has not been field-up and left for your consideration please. Furthur it is also very surprising and not understood as to how, the NOC under question be furnished, at the ends of the society, while the aforesaid colony is still unathorised and no NOC etc. has been issued to this Association, till date, by the Govt. of NCT Delhi or so.

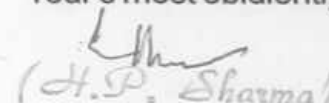
