

MEMORANDUM OF ASSOCIATION

1. Name of the Society

The Name of the Society shall be "PANCHSHEEL WOMEN'S WELFARE ASSOCIATION". herein offer referred to as an "ASSOCIATION".

2. Registered Office:

The registered office of the Association shall remain in the Union Territory of Delhi. At present it is at the following address.

C-153,  
Rastasal Colony  
Uttam Nagar, New Delhi-110059

3. Aims and Objectives

The main aim of the association shall be to do all work (technical and non technical) related to the upliftment of women's, tackling their problems and work for their total welfare. The other aims and objectives for which the association is established are.

- (a) To work for development, unity and integrity among women
- (b) To make aware women of their political, socio-cultural and legal rights.
- (c) To organise seminars/symposia on related aspects/problems of women from time to time
- (d) To open and organise a public library in the Union Territory
- (e) To organise Adult Education/Vocational activities to inculcate in them self reliance.
- (f) To provide employment opportunities through small scale Industries or any other cooperative and corporation
- (g) To manage and run a school, arts and crafts, tailoring centre etc.
- (h) to commission and promote research activities on different aspects related to their socio-economic upliftment and other problems.
- (i) To promote the activities to eradicate social and other evils.
- (j) To promote the natural utility of available resources to domestic and industrial needs.
- (k) to organise the mass-communication means for effective propagation of welfare.

"All the incomes, earnings, movable or immovable properties of the society shall be solely utilised and applied towards the promoting of its aims and objects only as set forth in the Memorandum of association and no portion thereof shall be paid or transferred directly or indirectly by way of dividends bonuses, profits or in any manner whatsoever, to the present or past members of the society or to any person claiming through any one or more of the present or the past members. No member of the society shall have any personal claim on any movable or immovable properties of the society or make any profits, whatsoever by virtue of this membership."

iv) The Governing Body shall set apart a Reserved Fund or Special Fund out of any income, endowments, loans, donations, Grants and contribution for specified purposes and for progressive financing of the activities of the Association. No part of such funds shall be utilized for purposes other than these specified.

#### 6. Financial year

The official year of the Association shall be the conventional financial year i.e. 1st April to 31st March.

#### 7. Audit of Accounts

(i) The account of the Association shall be audited by auditors appointed by the Governing Body. The nature of audit to be applied and the detailed arrangements to be made in regard to the form of accounts and their maintenance and presentation of the account shall be determined by the Governing Body from time to time.

(ii) The annual account of the Association together with the audit report thereon and an annual report of the proceedings on all work undertaken during the year shall be prepared by the treasurer and Secretary respectively on behalf of the Governing Body and shall be placed for approval before the General Body of the Association at the annual general meetings.

#### 8. Operation of Bank Account:

The bankers of the Association shall be a nationalised bank recommended by the Governing Body from time to time. A joint account shall be maintained by the Treasurer, President and the Secretary on behalf of the Association in its name. All financial transaction shall be with the Branch of the nationalised bank, where the account is maintained by the Association.

#### 9. Annual list of Governing Body (section 4 of the Act)

As required under Section 4 of the societies Registration Act, 1860, list of the office bearers and members of the Societies, Delhi shall be scrutinized once in every two years.

#### 10. Legal Proceedings (Section 6 of the Act)

The Association may be sued in the name of president/Secretary as per provision laid down under Section 6 of the societies Registration Act 1860 as applicable to Union Territory of Delhi.

- (iii) The Governing Body shall have the power to make/amend the bye-laws as it deems fit for the regulation of the business of the Association and regarding the appointment and selection of the research or administrative staff, their terms of service, preparation and sanction of budget estimates, the sanction of expenditure, the negotiation and finalization of contracts and investment of the funds of the Association.
- (iv) The Governing Body may by passing a resolution delegated to the President or an office-bearer or any committee/committees for such purposes and with such powers as it may deem fit and lay down rules of procedures for the working of such committees.

V POWERS AND DUTIES OF THE OFFICE BEARERS:

(a) President

The President shall be responsible for the overall supervision of the affairs of the Association under the direction and guidance of the Governing Body. He/She shall regulate the work of the Association undertaken in furtherance of its objectives as its technical and academic head. Moreover, the President shall be responsible for all administrative duties as the Chief Executive Officer of the Association. Control academic, professional and other staff, perform all duties and exercise all powers assigned/entrusted/delegated to him/her under these rules entrusted/delegated to him/her by the Governing Body.

(b) Vice-President.

In the absence of the President, the vice-President No.1 and in the absence of both, the Vice-President No.2 will act as President and exercise all the above roles and responsibilities entrusted to the President. In addition to this Vice-Presidents will be the Chairpersons on different committees/bodies as per the decisions of Governing Body.

(c) Secretary.

He/she shall keep or cause to be kept all records of the Association and shall be responsible for preparation and submission of various returns to the registration. Whoever may be keeping these records shall always be deemed to be his/her custody, possessions, power and contract. He/she shall be responsible for making over the charge of this record to his/her successor under proper charge report to be signed by the relieved officer.

(d) Joint Secretary.

In the absence of the Secretary, the Joint Secretary will hold the charge of the Secretary and perform all the duties assigned to the Secretary.

2. GENERAL BODY

(I) Definition:

General body refers to the General Body of the Association consisting of all the various categories of membership as prescribed in chapter II.

(II) Powers and duties/functions of the General Body

- (i) The General Body of the Association shall meet atleast once a year at a time and place as may be finalised by the Secretary with the approval of the Governing body to transact the following business:
  - (a) To elect, suspend or remove members of the office bearers of the Association for a period of two years.
  - (b) To approve the appointment of auditors by the General Body each year.
  - (c) To consider and approval the Annual Report prepared by the Secretary alongwith Annual Accounts of the Association submitted by the treasurer.
  - (d) To consider other matter in the agenda of which seven days advance notice has been given in writing to the President/Secretary and/or any other ancillary matter may be raised with the approval of the Chairman.

The Secretary may convene an extra ordinary general meeting of the members with the approval of the Governing body on the written requisition of not less than one fifth of the members of the Association with sufficient convincing grounds which shall be considered on its merits by the Governing body.

III. Quorum and notice of meeting and periodicity of meeting:

- (i) Two third of the member of the General Body constitute the quorum for the General Body meeting provided that in the absence of this quorum, the meeting shall stand cancelled.
- (ii) Fifteen days advance notice shall be given to all members to attend a General Meetings.
- (iii) In the event of a cancellation of meeting, the Governing Body shall be reconvened at the same place and time precisely seven days later without further intimation. In this reconvened meeting no quorum shall be necessary.

RULES AND REGULATIONS  
PANCHSHEEL WOMEN'S WELFARE ASSOCIATION

(I) Name of the Association

The name of the Association shall be "PANCHSHEEL WOMEN'S WELFARE ASSOCIATION". The Headquarters of the Association shall be situated within the Union Territory of Delhi. At present it is located at C-153, J.J. Colony, Hauz Khas, Uttam Nagar, New Delhi.

(II) Membership Defined

The membership of the Association shall consist of:

- (i) The persons (male or female) joining in the application for registration.
- (ii) Persons admitted in accordance with the bye-laws.
- (iii) Nominal or associated members subject to conditions.

(III) Admission and qualifications for membership

No person shall be a member unless;

- (i) he/she is a resident in or around the Union Territory of Delhi;
- (ii) he/she is not a member of any such registered association;
- (iii) his/her written application for membership has been approved by a majority of the members of Governing body;
- (iv) his/her age is not less than 18 years; and
- (v) all persons joining with the application for registration qualified for the membership shall be processed by the Secretary and forwarded to the Governing body for its approval.

(IV) Subscription

Every member on admission shall pay Rs. 10/- as admission fee which shall not be refunded in any case.

(V) Cessation of Membership

A person ceases to be a member:

- (i) On death.
- (ii) For lack of confirmation of membership as per bye-laws (ii) and (iii).
- (iii) When his/her resignation has been accepted by the Governing Body.






