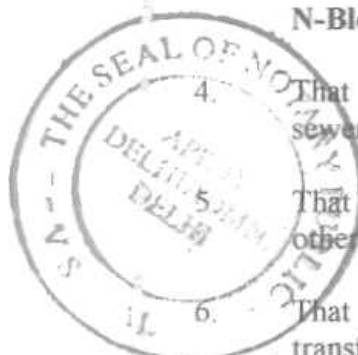

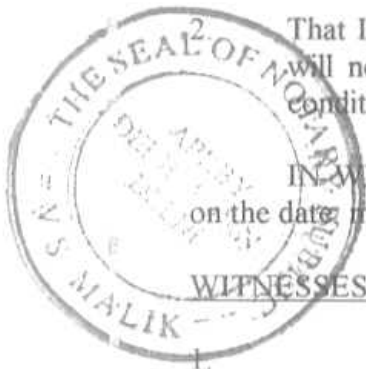

11. QUORUM AND NOTICE OF MEETINGS

a) The Quorum for an Executive Committee Meeting shall be FIVE out of whom at least two of the following bearers is a must.

- a) President of Vice-President.
- b) Gen. Secretary/ Treasurer/ Secy.

b) A minimum one week's notice is a must for the meeting of the Executive Committee provided that an emergency meeting could be called with only THREE days notice on the approval of the President.

c) Every meeting notice should have an Agenda for the meetings accompanied by the minutes of the previous meeting for rectification.

12. SOURCES OF INCOME AND UTILISATION OF FUNDS:

a) Main sources of income of Association shall be way of Admission Fee subscriptions, Contributions, Donations, Gifts.

b) Utilization of Funds of Association shall be purely to achieve the Aims and Objects of the Association Viz Welfare of the Members and their family members.

c) Financial year shall be from April to March of the succeeding Year i.e. March.
