I am deeply distressed to note that notices have been issued in respect of the colony which has been included in the list of 1639 colonies to be regularised. Its number in that list is at Serial No. 839 and comprises of built up area which was duly corroborated by the enquires/investigations conducted by Govt. agencies like DDA, DC office, aerial survey, etc. from time to time. The colony is in existence prior to 1991. The colony has metalled roads, 'nallies', approach roads, etc. The residents have Ration cards, Voters I Cards, electricity connections, water connections, etc.

The RWA of the colony also applied for its regularization in response to the applications invited by Delhi Govt. and has also been issued Provisional Certificate of Regularisation (copy enclosed). Further, it is pertinent to mention here that the poor people have built up small dwelling units by mustering their life long savings.
