1. NAME OF THE SOCIETY:

The name of the Society shall be

**"HARIT VIHAR RESIDENTS' WELFARE ASSOCIATION" HARIT VIHAR,
VILLAGE KAMALPUR MAZRA, BURARI, DELHI- 110084.**

2. MEMBERSHIP:-

The membership of the Association is open to any male and female migrated from different part of India and are living in Harit Vihar, Village Kamalpur Mazra, Papsi Road, Burari, Delhi- 110084, who has attained the age of majority (i.e. 18 years) and abide by the rules and regulation of the Association without discrimination of the religion, caste, colour or the creed but subject to the approval of the Governing Body.

3. SUBSCRIPTION:-

The rate of subscription for all the members shall be Rs. 5/- per month and admission fee Rs.20/-

4. REFUSAL:-

The Governing Body of the Society may refuse any person for membership in provided reasons for refusal shall be communicated to the person concerned in writing with reason.

5. EXPULSION:-

The Governing Body of the Society may expel any member from the Society on the following grounds:-

- a) On his/her death.
- b) If the member fails to pay the timely subscription continuously for three months from the due date of paying the subscription.

- e) If the member fails to attend three meetings of General Body and Governing Body.
- f) If the member fails to attend three meetings of General Body continuously without intimation.

6. APPEALS:-

- d) To appoint a qualified Auditor who will annually audit the accounts of the Society's funds.
- e) To consider any business brought forwards by the Governing Body.

10. GOVERNING BODY:-

There shall be a Governing Body of the Society to look after and to manage the day to day affairs of the Society. It shall consist of minimum 7 and maximum 21 members including the office bearers. The meetings of the Governing Body shall be held after every months with 1/3 quorum. No quorum required in the adjourned meeting. And emergent meeting of the Governing Body may also be summoned on the written request of 3/5 members be 5 days notice of the meeting. The notice period of the Governing Body shall be 10 days. The following business shall be transacted in these meetings:-

- a) To take necessary steps for the implementation of all the programmes and policies drawn by the General Body.

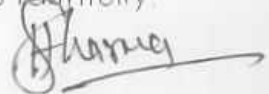

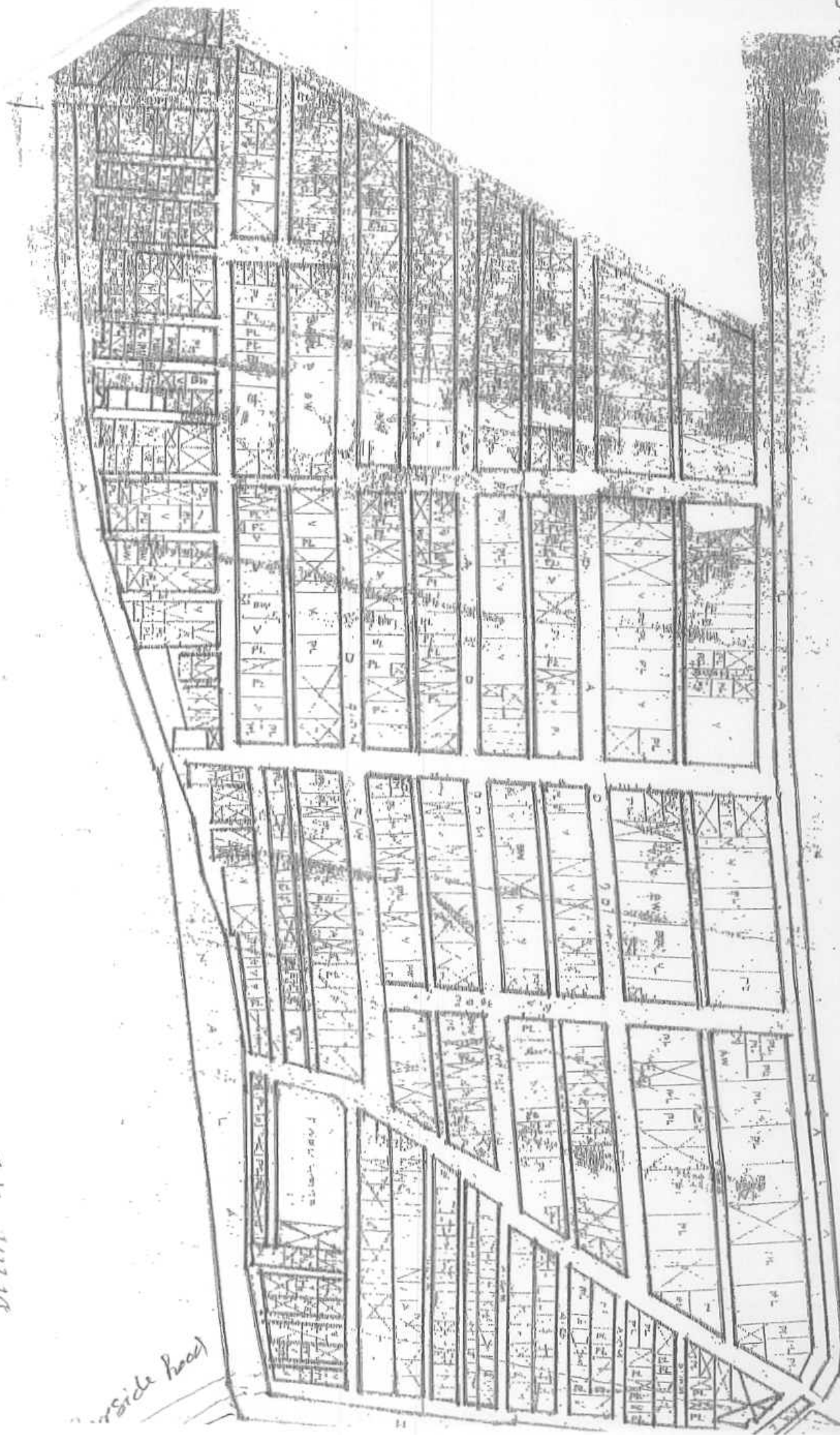

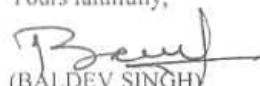

With humble regard we wish to present the following for your kind consideration.

Harit Vihar is one of the oldest colonies of its surrounding areas.

The colony has been in existence almost last 33 years (i.e. since 1974). The area of this colony is 12 Hect. and present population over 10 thousand. I appreciate you sir to regularize 1500 unauthorized colonies by your Party, State Government and Centre Government in Delhi State in the months of January, 2007 under Master Plan 2021, Harit Vihar, Village Kamalpur Mazra, Burari, Delhi - 110084 is the one of the Colony in your Constituency. All this stated to present the importance of this colony in its surroundings. But on the other side the colony is far behind in terms of development. There are 11 streets (i.e. 4, streets are 9 Meters wide with 3, cuts of 9 Meters and 4 streets are 6 Meters wide), with nearly 35 streets (i.e. 3 Meters, 4.5 Meters and 5 Meters wide) total nos. come to approximately 50, in 33 years one streets was constructed.

A colony of this magnitude needs to be developed in a well planned manner without which all funds spent on tit-bits of development may go waste as has been happening till now. Our Association has witnessed the various development works here and there without any proper plans, which in course of time go waste because these are not part of an overall development plan. One street constructed without a proper drainage outlet, do not serve the purpose for long. Once the drains get chocked water spills over and damages the street surface.

As evident from above little useful work has been done in this colony. It shall require some sort of special attention and special sanction of amount, for a viable development work, which may become the actual development of the area. Our Association therefore, has prepared a plan for over all development of Roads/streets land drainage in this colony. I present it here for your kind consideration.

Hon'ble Sir it was not our job to do this scheme making but we wanted to present our colony's actual conditions and seek a solution for good. Such an old colony could not be developed all these long years and whatever little was done here and there has not improved the situation. We feel by your graceful attention our colony shall see some actual improvement now.

The detailed development plan worked out by our Association is attached herewith for your kind perusal:-

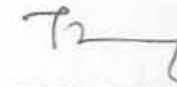

Kindly refer to your letter No.1694 dated 03.05.2007 addressed to Hon'ble Minister of Urban Development requesting for development of roads/streets and drainage in Harit Vihar, Pepsi Road, Burari, Delhi.

The matter has been examined in this Deptt. As per the present policy roads and drains in unauthorised colonies located on private land are being constructed which are in the list of 1071 unauthorised colonies that are existing prior to 1993. The name of unauthorised colony Harit Vihar, Pepsi Road, Burari is not figuring in the list of 1071 unauthorised colonies. As such as per the policy, it is not possible to construct roads and drains in this colony presently. However, the name of this colony is figuring in the list of 1432 unauthorised colonies proposed to be considered for regularization. The Union Cabinet has approved a proposal for regularization of these unauthorised colonies and the policy guidelines are awaited from Ministry of Urban Development. Once the policy guidelines from Govt. of India is received Govt. of Delhi would chalk out the programme for development of these unauthorised colonies wherein all facilities would be provided.

Kindly refer to your letter No.1694 dated 03.05.2007 requesting for development of roads/streets and drainage in Harit Vihar, Pepsi Road, Burari, Delhi. The matter has been examined in this Deptt. As per the present policy roads and drains in unauthorised colonies located on private land are being constructed which are in the list of 1071 unauthorised colonies that are existing prior to 1993. The name of unauthorised colony Harit Vihar, Pepsi Road, Burari is not figuring in the list of 1071 unauthorised colonies. As such as per the policy ~~evoked~~ it is not possible to construct roads and drains in this colony presently. However, the name of this colony is figuring in the list of 1432 unauthorised colonies proposed to be considered for regularization. The Union Cabinet has approved a proposal for regularization of these unauthorised colonies and the policy guidelines are awaited from Ministry of Urban Development. Once the policy guidelines from Govt. of India is received Govt. of Delhi would chalk out the programme for development of these unauthorised colonies wherein all facilities would be provided.
