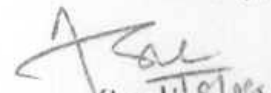

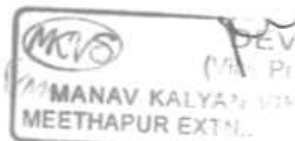

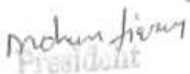

6. APPEALS:-

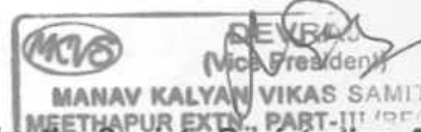

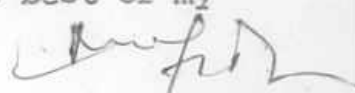

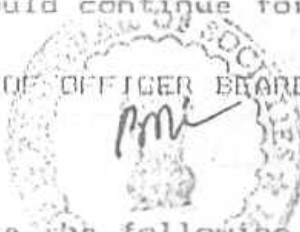
