1. NAME AND AREA OF OPERATION OF ASSOCIATION

The Name of Association shall be **"SITAPURI PRAGATI SANSTHA"**.

1A. Area of Operation : National Capital Territory of Delhi

2. REGISTERED OFFICE

The Registered Office of the Association is situated at D-105, Sitapuri, New Delhi-110 045 or at such places as the Governing body may from time to time decide. The Registered office shall remain and be in the Union Territory of Delhi.

3. AIMS AND OBJECTIVES

- 1) To work for social, moral & cultural upliftment of the members of the association in particular and people in general.
- 2) To work for the welfare of the people living in and around the area of SITAPURI and Co-ordinate with the other Resident Welfare association as well,
- 3) To Provide round the clock security to the member of the association by keeping security men & with the help of Delhi police, home guards, Civil Defence personnel's.

RULES AND REGULATION

1. NAME OF THE ASSOCIATION

The Association shall be called **"SITAPURI PRAGATI SANSTHA"**.

1A. Area of operation : National Capital Territory of Delhi

2. REGISTERED OFFICE

The Registered Office of the Association shall be situated at or such places as the Governing Body may from time to time decide. Registered Office shall remain and be in the union territory of Delhi and at present it is at the following address:

SITAPURI PRAGATI SANSTHA

D-105, SITAPURI, NEW DELHI-110 045

3. DEFINITIONS & RELATED CLAUSES

- a) In these bye-laws, there is anything repugnant to or inconsistent with the subject or context, the expression "the act " or "act" means the societies registration act, 1860 applicable to the National Capital territory of Delhi and its words and expressions as defined in the act and used in these bye-laws shall have the same meaning as assigned to them in the said act and rules thereunder.
- b) "Government " henceforth refers to the central government as well as the state Government
- c) "members " henceforth refers to the members of the association
- d) "Auditors " refers to the auditors as defined in the chartered accountants regulation act.
- e) "the office " means the registered office of the association
- f) " The office bearer" means a) the president b) the secretary and c) the treasure.
- g) "Years " means the year commencing from April of a particular year and ending with March of the next year
- h) "General body" means all the member of the society
- i) " Executive committee or governing body " means the council that shall exercise full power on behalf of the association.

4. MEMBERSHIP

The Membership of the associations will be open to all residents of SITAPURI, who have attained the age of majority and is of sound mind and agrees to abide by the rules and bye laws of the association The residents may be allottee/purchaser/ occupier or their legal heirs.

Any person shall be admitted as member on written request along with the payment of admission fee of Rs. 100/- (Rupees one hundred only) or as may be decided from time to time by the governing body. Provided however that the governing body shall have power to

admit any person as member without requiring him to pay the admission fee. If the membership is refused to any person, the reason for refusal shall be communicated to the person concerned.

Honorary Members

Any person who has rendered eminent service to the society or show on account of their professional & technical and/or experience is in position to render valuable help or advice and whose connection with the association is considered desirable or beneficial, may be nominated as the honorary member of the society. He may not be required to pay any fees / subscription.

5. SUBSCRIPTION

General members shall have to pay membership of Rs. 20/- (Rupees Twenty only) monthly or Rs. 200/- one time yearly payment. The same may be modified as per approval of the majority of the members in the annual general meetings.

6. REGISTER OF MEMBERS

There shall be maintained in the office of the Society a register of members in which shall be entered the following particulars.

- a) the name and address of each members
- b) the occupation of each members
- c) such other information as the governing body may be prescribe

Every member shall notify the secretary of any change in his/her address or any other particulars furnished in his/her application for membership.

7. CESSATION AND RE-ADMISSION OF MEMBERSHIP

A member shall cease to be a member of the society in the following events:

- (a) if he resigns
- (b) if he is adjudged insolvent or of unsound mind or is convicted for an offence which in the opinion of the Governing Body is harmful to the interest of the Society.
- (c) If he fails to pay his subscription or dues continuously for six months for the due date or for such an period as may be decided from time to time by Governing Body
- (d) If the members works against the objects, rules and regulation of the Society
- (e) If a member expires.
- (f) If he is involved in moral turpitude.
- (g) If the conduct of any member is deemed by the Governing Body to be prejudicial to the interest of the Society, that member shall be liable to suspension or expulsion from Society by a resolution passed by majority present in the meeting of the Governing Body. The decision of the General Body shall be final and that shall be communicated to the person concerned

A member may be re- admitted upon the recommendation of the Governing Body.

8. GENERAL BODY

General Body of the Society will consist of all members who have not been disqualified by the Governing Body.

9. FUNCTION OF THE GENERAL BODY,

The General Body will be the supreme policy making body of the Society and shall be vested with the following powers:

- (f) He is to administer oath of the office and loyalties to the Society and/or its constitution to the president.
- (g) He shall be bound by the Rules & Regulations and the bye-laws of the Society framed from time to time.

Duties of the members of the Society

- (i) Prior permission from Governing Body must be obtained for selling and/or renting the society flats/properties and for any change in status que.
- (ii) Pets and other animals should not be allowed within the society premises without prior approval of the Governing Body .
- (iii) In case of any dispute between the members, it should be brought to the notice of the Governing body of the Society. The decision of the Governing Body shall be final and binding on both the parties.

12. EXECUTIVE COMMITTEE OF THE ASSOCIATION & TENURE

The Founder members of the Society shall from the First Executive Committees of the Society and they shall be in office for a period upto conclusion of the First Annual General Body meeting. The period of the Body shall be Five years.

13. POWERS & DUTIES OF EXECUTIVE COMMITTEE

Subject to the provisions of the memorandum, the Governing Body shall have powers: -

- (i) To prepare and execute detailed plans and programmes for the establishment of the Society and to carry on its administration and management after such establishment.
- (ii) To receive grants, donations and contribution and to have custody of funds of Society.
- (iii) To open and operate bank accounts with the cashier/Treasurer.
- (iv) To lay down the general policy for the attainment of the aims objectives of the Society
- (v) To decide venue and date of the Annual Meetings.
- (vi) To fill up vacancy in the Executive Committee and get it approved in the next General Body Meeting.
- (vii) To meet atleast FOUR Times a year
- (viii) To approve the audited accounts along with the audit reports.
- (ix) To create, receive and administer funds,
- (x) To enunciate, define or determine the powers and duties of any or all the office bearers of the Society.
- (xi) To appoint Sub - committees and/or Advisory Councils for specified purposes and with such powers as may be considered necessary or desirable.
- (xii) To take all necessary steps to realise any arrears of money due to the Society and write off any sums which are irrevocable in the opinion of the Executive Committee.
- (xiii) To take Into consideration for necessary actions any resolution that may have been passed on any item of the agenda of the Annual General Body meetings.
- (xiv) To recruit the staff and lay down methods of recruitment and conditions of their service
- (xv) To do all such things as may be considered necessary or incidental or conducive to the attainment of the objects of the Society.

14. COMPOSITION OF GOVERNING BODY :

1. President

one

- (a) To elect the Governing Body members through proper election.
- (b) The General Body also has the power to remove from office any members of the Executive Committed other members if he violate the Rules and Regulations of the Society or works against its interest.
- (c) To consider and approve the audited statements of accounts of the Society for the preceding year with the Auditor's Report thereon and adoption of the same with such modification as may be deemed proper.
- (d) The budget of the Society and the Expenditure incurred by it will be approved by the General Body.

10. MEETINGS OF GENERAL BODY

The general body shall hold it's Annual General Meetings once in a year. Extra ordinary general meeting can be called at any time to transact important and urgent matters. At the meeting following business shall be transacted:

- (a) Confirmation of the minutes (for the proceedings) of the last meeting.
- (b) To consider audited statements of the activities of the Society.
- (c) To consider the budget financial statement of the ensuing year
- (d) Appointment of the auditors for the following year.
- (e) Any proposal approved by executive committee.
- (f) The Executive Committee of the Society will be elected once in every FIVE years. They are eligible for re-election. In case there is resignation or retirement of membership for any other reason, another member may be nominated by the Executive Committee to be ratified by the General Body in its next meeting.
- (g) Such others matter that may be permitted by the chair at the time of meeting.

In urgent cases, the approval of the members could be taken through circulation of the proposal.

In cases of difference of opinion amongst the members, the opinion of the majority shall prevail but in case of equality of votes, the president shall be entitled to have a casting vote.

QUORUM OF GENERAL BODY MEETING

The quorum of general meeting shall be minimum 4 members or Two-third of total members, whichever is higher.

NOTICE OF MEETINGS

The notice for meeting shall be given to the members at least two days in advance.

11. MEMBERS RIGHTS, PRIVILEGES & DUTIES

Every member person enrolled as member shall enjoy all rights and provisions assured by the constitution of the Society and the rules framed thereunder provided he doesn't suffer from any disqualification as mentioned above.

- (a) He has a right to vote at every meeting
- (b) He is entitled to participate in the meetings and religious and/or cultural functions and other lawful gathering called or arranged by the Society.
- (c) He has a right to inspect the books of accounts and the minutes of the proceedings of the Society.
- (d) He has right to elect the Executive Committee.
- (e) He has a right to attend General Body meetings.

TREASURER

The treasurer shall diligently look after the financial interest of the Society under the general guidance of the president, it shall be the duties of the treasurer to:

- (a) Arrange for the custody and maintenance of the books of account.
- (b) See the bank account of the Society is properly maintained and the security of the Society are kept in safe custody.
- (c) Arrange for the audit of the Society.
- (d) Perform all such other duties and functions that pertain to his office that may be entrusted to him by the president.
- (e) To keep a maximum of Rs 5000/- at one time with him and any amount in excess is deposited in bank immediately.
- (f) To look after the realization of fees and other dues with the help of General Secretary and prepare a list of defaulting members if the arrears are for more than three months and submit it to the Executive Committee for action.

16. RESIGNATION OF OFFICE BEARERS

- (a) All resignations shall be intimated to the General Secretary for consideration by the Executive Committee or the General Body as case may be All dues must be cleared properly before the resignation can be accepted.
- (b) An office bearer shall, in addition, formally make over the charge of the office.
- (c) The General Secretary and Treasurer may submit resignation to the president.

17. VACANCY

The General Secretary before vacating office shall hand-over the charge to the Joint Secretary. Committee designated by the president.

The Treasurer when vacating office shall hand over the charge to the General Secretary.

The vacancy shall be filled up by the Executive Committee nominations, if it happens within a year, to be ratified by the general body in its next meeting.

18. FINANCIAL YEAR

The financial year will be form 1st April to 31st march of the succeeding year.

19. SOURCES OF INCOME AND UTILIZATION OF FUNDS

The funds of the society will consist of the following:

- (a) Grant - in aid from Government and other Authorities.
- (b) Contribution and donations from other sources.
- (c) Fees and subscription of the members.
- (d) Income from investment in Government Securities etc.

The funds of the society, other than used for usual running of the Association shall be kept in the following manner:

- (a) in trust securities
- (b) by way of shares or securities or deposit with such limited liability companies as may be considered safe and remunerative by the Executive Committee
- (c) The corpus and other funds shall be invested as per the provision of the section 11 (5) of the income tax act and the provisions of the said section in this regard are strictly adhered to.

15. POWERS AND DUTIES OF OFFICE BEARERS

PRESIDENT

Without prejudice to any of the powers conferred on the Executive Committee in these rules, the president shall have absolute control and be in absolute incharge of the management and affairs of the Society and in particular shall have powers to provide of the following matters.

- (a) Preparation of budget estimates.
- (b) Sanctioning of Expenditure.
- (c) Subject to the approval of the Executive Committee, making and execution of contracts, investment of funds of Society, alteration of such investment.
- (d) To verify and finalise the accounts and audit and annual report.
- (e) To preside over all the meetings of the Society.
- (f) To give a casting vote if the votes are in equal numbers.
- (g) To call an emergency meeting in consultation with the Secretary.
- (h) To appoint/fix the remuneration of, to promote, suspend, dismiss its employees.
- (i) To co-ordinate and exercise general supervision of overall activities of the Society.
- (j) To provide for day to day management of the affairs of the Society.

VICE- PRESIDENT

To perform all the functions of President in his absence

GENERAL SECRETARY

- (a) The secretary shall convene meetings of the Executive Committee by issuing notice of TWO days and shall implement and follow up all the decisions taken by the Executive Committee. An urgent meeting shall however, be called at twenty - four hours notice if desired by the president.
- (b) To look after the incomes and expenditure of the Society and to pass regular payments.
- (c) To pass any incidental and unexpected expenditure upto Rs. 500/- at a time.
- (d) To maintain an up to date register of members of the Society.
- (e) The general secretary shall see that all records, documents etc are properly kept at the head office and nothing is removed or shifted without any valid reasons.
- (f) To shoulder responsibility of management or day to day working of the Society.

JOINT SECRETARY

To perform all the functions of President in his absence

All the incomes, earning, movable, immovable properties of the Society shall be solely utilized and applied towards the promotion of its aims and objects only as set forth in the Memorandum of Association.

And no profit or loss shall be paid or transferred directly or indirectly by way of dividend, bonus and profit or in any other manner whatsoever to present or past members of the society or to any person claiming through any one or more past members

No members of the society shall have any personal claim on any moveable or immovable properties of the Society or make any profits, whatsoever, by virtue of his membership.

20. BANK ACCOUNTS

The account shall be opened in the name of SITAPURI PRAGATI SANSTHA with any bank approved by the executive Committee.
