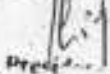

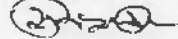

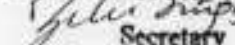

7. **FUNCTIONS OF THE GENERAL BODY:-** The functions of the general body are as follows:-

9. **MANAGING COMMITTEE:-** The Managing Committee shall consist of not less than four members including office bearers and not more than thirteen members including office bearers. The members of the Managing Committee shall hold office for one year. The meetings of the Managing Committee shall be held when necessary and notices required within three days and the quorum shall be four out of thirteen. Adjourned meeting shall be held within three days and no quorum shall be necessary for the same.
10. **RESIGNATION:-** The resignation submitted by the any of the office bearers shall be accepted by the Managing Committee in the Managing Committee meeting.
11. **VACANCIES:-** If any of the office bearer on account of resignation or otherwise vacate the office, the vacancy will be filled up by the general body in its next meeting. The vacancies made by the rest of the office bearers or members will be filled in the Managing Committee.
12. **FUNCTIONS OF THE MANAGING COMMITTEE:-**
 - (a) to arrange finance if required from other institutions Banks or individually on reasonable terms and conditions and the Managing Committee as a whole liable for its return;
 - (b) as a whole the Managing Committee shall be responsible for implementation of the decision taken by the general body and to make plan for the future programme of the society;
 - (c) In order to achieve the aims and objects of the society the Managing Committee as a whole is empowered to do all such things as may be necessary.

The following are the provisions of the Rules
& Regulations of the proposed society.

- .-.-.-
1. **MEMBERSHIP:-** The membership of Sarup Nagar Welfare Society shall be open to any person without discrimination of caste, colour and creed but subject to approval of the Managing Committee.
 2. **SUBSCRIPTION:-** Subscription of the society shall be as under:-
 - (1) Membership fee at the time of Admission 5/-.
 - (2) Subscription shall be Rs.1/-only per month.
 - (3) Patron and life member will pay Rs.100/-once only;
 3. **TERMINATION OF MEMBERSHIP:-** The managing committee shall have the power to expel a member from the Society if a member:-
 - (1) has not paid his monthly subscription for more than three months;
 - (2) if he does not attend three meetings of the Society without any intimation;
 - (3) on the written resignation;
 4. **APPEALS:-** All the appeals should be sent to the Managing Committee of the Society, the decision of the Managing Committee will be final.
 5. **RE-ADMISSION:-** In the case of the member expelled on account of non payment of due he can be re-admitted by the Managing Committee provided the member concerned pays all upto date dues alongwith Rs.5/- as Re-Admission fee. Decision of the Managing Committee will be final in all re-admission cases.
 6. **GENERAL BODY:-** It shall consist of all members of the above category for a period of one years on the membership roll and as are not disqualified by the prior resolution if any, of the Managing Committee
 - (1) there shall be an annual meeting of the General body within a month after Diwali;
 - (11) there may be summoned a special, general body meeting for transaction urgent business;

2. The Registered office of the Society shall situate in the Union Territory of Delhi at present it is at:-

3. Aims & Objects:-

- (1) to represent and seek help of authorities for procuring amenities and facilities like modern drainage system, water system, electricity, pucca lanes, roads, children park, school education, cinema;
- (2) to represent and seek help of authorities for modern type reading rooms for general use among the members, and imparting adult education. For the workshop and diffusion of religion teachings, temple/gurudwara would be constructed. 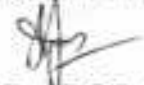
