



RULES AND REGULATIONS OF THE SOCIETY NAMED SARUP NAGAR  
WELFARE SOCIETY

The following are the provisions of the Rules & Regulations of the proposed society.

1. **MEMBERSHIP:-** The membership of Sarup Nagar Welfare Society shall be open to any person without discrimination of caste, colour and creed but subject to approval of the Managing Committee.
2. **SUBSCRIPTION:-** Subscription of the society shall be as under:-
  - (1) Membership fee at the time of Admission 5/-.
  - (2) Subscription shall be Rs. 1/- only per month.
  - (3) Patron and life member will pay Rs. 100/- once only;
3. **TERMINATION OF MEMBERSHIP:-** The managing committee shall have the power to expel a member from the Society if a member:-
  - (1) has not paid his monthly subscription for more than three months;
  - (2) if he does not attend three meetings of the Society without any intimation;
  - (3) on the written resignation;
4. **APPEALS:-** All the appeals should be sent to the Managing Committee of the Society, the decision of the Managing Committee will be final.
5. **RE-ADMISSION:-** In the case of the member expelled on account of non payment of due he can be re-admitted by the Managing Committee provided the member concerned pays all undated dues alongwith Rs. 5/- as Re-Admission fee. Decision of the Managing Committee will be final in all re-admission cases.




