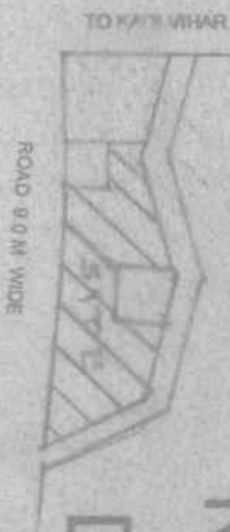


KEY PLAN OF D - BLOCK NATHU PURA
