 - D. Those connected with or in relation to and/ or otherwise to regulate and/ or to solve and remove problems of welfare, illiteracy, ignorance and to campaign against drug addiction and moral degradation.

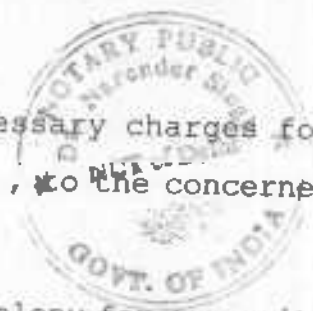
