

Introduction

9,11410

1. The name of the society is PLOTE ON NER WELFARE ASSOCIATION DEFENCE ENCLAVE PART -I, MOHAN GARDEN.

2. In these Rules, unless the context otherwise requires, words or Expression defined in the societies Registration Act XXI of 1860 as extended to the Union Territory of Delhi or in any other statutory modifications or reenactment there of shall have the meaning as defined therein.




