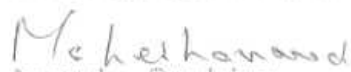

2. मैंने इस मामले की जांच करवा ली है। राष्ट्रीय राजधानी क्षेत्र दिल्ली सरकार ने बताया है कि अनधिकृत कालोनियों में पानी, बिजली, सड़कें और जल निकासी जैसी मूल सुविधाएं माननीय दिल्ली उच्च न्यायालय के दिनांक 19.8.1994 तथा 17.8.1998 के आदेशों के अनुसरण में मुहैया कराई जाती हैं। ये सुविधाएं उन कालोनियों में मुहैया कराई जाती हैं जो कालोनियों की सूची में शामिल हैं और मार्च, 2002 तक जिनमें 50% से अधिक निर्मित क्षेत्र था। श्याम विहार, रौशनपुरा और दुर्गा विहार कालोनियों में सड़कों व नालों के निर्माण की अनुमति दी गई है। शान्ति विहार और दीनपुर कालोनियां 1071 कालोनियों की सूची में शामिल नहीं हैं अतः राष्ट्रीय राजधानी क्षेत्र दिल्ली सरकार की वर्तमान नीति के अनुसार इनमें सड़कों और नालों के निर्माण पर विचार नहीं किया जा सकता।

2. Durga Vihar Phase-2 colony is listed at 172 and 173 in the list of unauthorized colonies. On direction of State Govt we have deposited our colony map and files at Delhi Seett vide their receipt No 16 dated 12 Dec 2007. The Govt has very kindly permitted for development work in such colonies.

3. Following projects have not been completed since last one year due to which thousands of residents are facing hardships and no one is ready to help them out till date:-

- a. Gali No 5 between Pole No 2185 - 87, 2194 - 95, 2203 - 07 & 2211. Two and half feet drain on both side street constructed which is full of muddy water generating a lot of insects and mosquitoes. No outfall constructed to flow waste water. Road is one feet down and waiting construction since last 1 year.
- b. Gali No 8 between Pole No 2250 to 2256. Below standard drain on one bank of street has been completed. On other side one portion of 100 feet and other 50 feet has been constructed and 10 feet left out in the middle due to which people are throwing water with the mug from the drain as without connectivity water can not flow either side. Road construction also not being planned since last one year and people are forced to suffer.
- c. Gali No 4 between Pole No 2236-37, 2193, 2260, 2202 & 2252. Below standard drain construction done eight months back. The road construction has been left out and people are suffering being 1 feet down from other places.

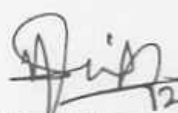

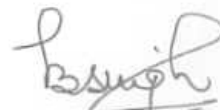

These works shall be executed by the MCD strictly in accordance with following points:

(i) As per the decision of the Cabinet dated 20.11.07, as far as possible, the cement concreting roads in unauthorized colonies be done where water lines or sewer lines or any other services are to be laid thereby obviating the need to frequently cut the roads.

(ii) The works shall be carried out only in the layout plans as available in the record against the unauthorized colony.

(iii) MCD shall ensure that the amount spent does not exceed the budget amount allocated to it for the current financial year 2008-09.

(iv) The work shall be undertaken strictly as per the policy of GNCTD and in the manner consistent with the order of the Hon'ble High Court of Delhi in CWP No.4771/1993. The work may be taken up strictly as per instruction issued from time to time by UD Deptt., Govt. of NCT of Delhi. While selecting the roads due care be exercised that proposed roads cater to the maximum traffic/population of the colony and does not pass through the vacant area of the colony.

(v) Work shall be carried out on private or Pvt./VGS land only.

(vi) The work shall not be carried out in following types of unauthorized colonies:

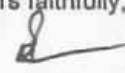
(a) Colonies/part of colonies falling on Govt. land/Original Gaon Sabha land/ Notified or reserved forest areas.

(b) Colonies/part of colonies which pose hindrances in the provision of infrastructure facilities or fall in the area of ROW of existing/proposed railway lines, master plan roads and major/trunk water supply and sewerage lines.

(c) Colonies located on ASI land or if it violates the provision of ancient monuments and Archaeological sites and Remains Act, 1958.

(d) Residential building used for non-residential purposes except those covered under the mixed land use regulations contained in the Master Plan for Delhi-2021.
