1. Name of society : The name of the society shall be "GOVIND COLONY JHANGOLA WELFARE SOCIETY."
2. Regd. Office : The Registered office of the society shall remain in the National Capital Territory of Delhi at present it is House No.77, Khara Khurd, Delhi-82. The area of operation will be at Delhi.

AIMS AND OBJECTIVES:

The aims and objectives for which the society is established shall be as under:-

1. To protect all the legal rights of the members of the society and the residents of GOVIND COLONY JHANGOLA residing in the GOVIND COLONY JHANGOLA WELFARE SOCIETY and to initiate and defend the legal proceedings in this regard.
2. To provide education to the General public, the poor, the needy, widow, handicapped, orphans, destitute, mentally retarded persons, poor students from O.B.Cs., B.Ts. & S.Cs. weaker section and wards of martyr soldiers etc. as per rules and regulations of the Govt. Authorities.

3. To establish, found and maintain as per various programs-guidelines of Govt. or Local Bodies Libraries/ Recreation Centres/Reading rooms for the educational institutions run by the trust for the benefit of community irrespective of caste, creed, race or religion.
4. 7. To make best efforts for protection, promotion, advancement of helpless persons or children, old aged persons, handicapped, orphans, destitutes and mentally retarded persons of the society. And to work generally for all round development of women, children, handicapped, dumb and deaf, mentally retarded and socially backward people of the locality.

8. To make best efforts to remove the social evils from amongst human beings, such as dowry-demand, child-marriage, use of intoxicated drugs (drug addiction), alcoholism and untouchability etc.

9. To consult the appropriate and proper authorities for seeking help in organizing festivals for general public and organizing Puja-Path/Ardas, Bhandara etc. in the locality for the benefits of the general public without any discrimination.

10. To arrange meetings, conferences, seminars, lectures in regard to upliftment of religious, social and moral status of general public. And to promote spiritual advancement and to develop a sense of discipline.
