2. To acquire, purchase, take on lease, hire, gift and any movable and immovable property(s) or any rights, titles or privileges that may be deemed necessary or useful for the advancement of the objects of the Society and to open the branches of the Society and to conduct the activities in the country.
3. All the incomes, earnings, movable and immovable property(s) of the Society shall be solely utilised and applied towards the promotion of its aims and objects only as set-forth in the Memorandum of Association and no profit thereof shall be paid or transferred directly or indirectly by way of bonus, profit, dividends, or any manner whatsoever to the present or past members of the Society or to any person or persons claiming through anyone or more of the present or past members. No members of the Society shall have any personal claim on any movable and immovable property(s) of the Society or make any profit whatsoever by virtue of this membership.

- (e) To make adequate arrangements for poor, widows, orphans, handicapped and mentally retired person or persons.
- (f) To organise discussions and seminars.
- (g) To publish books, charts, illustrations and other publications for the promotion, protection and advancement of residents of the Society.
- (h) To approach with the authorities concerned in redressing the social grievances of the members.
- (i) To give the informations of the Government Rules, Policies, notifications to the members of the Society in the common goods and common interest of the residents of the above said area.
- (j) To arrange for the services like plumbers, electricians, security and sweeping etc.
- (k) To arrange and establish medical and charitable dispensaries, family welfare clinic etc.
- (l) To help and assist poor and needy person(s)/residents and their family during emergencies such as flood, war, earth-quake, etc.
- (m) To do all such other acts, deeds and things for the common goods and common interests of the residents of the above said area.
