3. AIMS AND OBJECTIVES :

The aims and objectives for which this Society/Federation are established are as under :-

- i) To create a sense of brotherhood, co-operation, mutual harmony, love and affection amongst the members of the Society/Federation and also amongst the general public.
- ii) To organize seminar on social justice, educational and economical upliftment, and to raise legal demands for the protection of fundamental rights provided by 'Constitution of India' ^{legal empowerment} to work for legal empowerment of general public.
- iii) To open, found, establish, promote, set up, run, maintain, assist, finance, support and/or help the various community development programmes/activities and also construct and develop the Community Halls, Shochalay, Charitable Dispensaries, Libraries and other buildings/institutions for use and welfare of the general public.
- iv) To establish, maintain or grant aid for the establishment and maintenance of Roads, Khadanja, parks, Sewerage, etc.
- v) To take up effective but reasonable and lawful steps for the eradication of social evils such as Dowry System Wastage of money in various functions, ^{Flu & AIDS} use of intoxicated drugs, Child Marriage (Bal Vivah) and Child Labour, etc.
- vi) To take up effective, reasonable and lawful steps for the solution of problems relation to members of the Society/Federation may deem fit and proper.
- vii) To promote social, cultural and educational activities particularly for farmers, labour-class, weaker sections, women, children and others in general.
- viii) To propagate, impart and adopt any audio-visual methods for solving the problems of social evils like crime and corruption and help in the inculcation of such behaviour as would bring happiness to mankind without reservation of his status, caste, religion etc.

- ix) To inculcate the spirit of adventure love of nature, sense of equality, patriotism, fraternity, love and mutual help and to work for the social educational and spiritual upliftment of the members of the society and general public especially farmers, labour-class, villagers, children and the women folk.

- xiv) To promote plantation and environmental activities and development of non-conventions energy resources and to work and undertake activities for the protection and preservation of environment and on other issues related to environment like plantation, forestation, soil preservation, water shedding, organic farming, waste disposal, management/disposal and awareness against the use of hazardous chemicals etc.
- xv) To work and undertake activities for promotion and preservation of cultural and education heritage and to work for the up-keepment and protection of the monuments of national/international importance.
- xvi) To work for disable and handicapped person and to establish and maintain institutions for the handicapped and for adult education, like vocational training in vocations of house hold industry, semi-skilled jobs for self employment, short hand type writing, computer, social science, dancing, physical training etc, etc.

1. Short, Title, Commencement and interpretation.
- I SOCIETY/FEDERATION Means FEDERATION OF RESIDENTS WELFARE ASSOCIATIONS OF NAJAFGARH, NAJAFGARH, NEW DELHI, .
- II Act means Societies Registration Act XXI 1860 (Punjab) amendment Act, 1957 as extended to the Union Territory of Delhi.
- III MEMBER means member who is entered in the register of Members of the FEDERATION OF RESIDENTS WELFARE ASSOCIATIONS OF NAJAFGARH.
- IV GOVERNING BODY means Governing Body appointed by the General Body.
- VI FINANCIAL YEAR mean the period of 12 months commencing from 1st April, every year.
- VII GENERAL BODY means all the members of the Society/Federation who are entitled to vote at the General Body Meeting.
- VIII The FEDERATION OF RESIDENTS WELFARE ASSOCIATIONS OF NAJAFGARH , DELHI can have its own rules and regulations subject to the restrictions of the Act.

All the provisions of the Societies Registration Act, 1860, will apply.

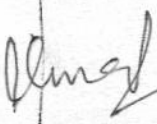
2(I). MEMBERSHIP

- A. The FEDERATION OF RESIDENTS WELFARE ASSOCIATIONS OF NAJAFGARH shall have two categories of members i.e (i) general body member (ii) volunteers.

ii) General Body Member

- a) A person who subscribes Rs. 100/- per annum and admitted by the governing body by two-third majority after the completion of one year by him as volunteer shall be called an individual member and is entitled to vote at the General Body Meeting of the FEDERATION OF RESIDENTS WELFARE ASSOCIATIONS OF NAJAFGARH, DELHI.

iii.) Volunteers :-

- a) A person who subscribes Rs. 100/- per annum shall be called an volunteer and is not entitled to vote at the General Body Meeting of the FEDERATION OF RESIDENTS WELFARE ASSOCIATIONS OF NAJAFGARH .

- X b) Institutional membership fees Rs. 150/- per year, not entitled to vote.

- c) A person whose subscription is in arrears for a period of more than three months after the close of previous financial year, shall automatically cease to a member. However, membership will be restored if the arrears are paid by the members along with payment of fresh membership fees.

- d) Membership fees Rs. 50/- (One time)

Annual Subscription Rs. 100/- (for individual members)

2(ii) CESSATION OF MEMBERSHIP

- a. Any member acting against the Society/Federation can be remove from membership through no confidence motion passed in a meeting by three fourth majority of Governing Body.
- e. The members desirous of withdrawal from membership may do so but the membership fee will not be refunded.
- f. By the death of the member.
- g. A person whose subscription is in arrears for a period of more than three months after the close of previous financial year, shall automatically cease to a member. However, membership will be restored if the arrears are paid by the members along with payment of fresh membership fees.

3. GOVERNING BODY OF THE FEDERATION OF RESIDENTS WELFARE ASSOCIATIONS OF NAJAFGARH

- a. The Governing Body shall consist of 7 members in which not less than 4 shall be executive office bearers.

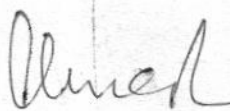
- b. The members of the Governing Body shall be elected as its annual General Body Meeting and shall retire at the conclusion of every Annual General Body Meeting. The Annual General Meeting shall be called with a specific notice interalia to elect the member of the Governing Body
- c. The Governing Body shall ordinarily meet any number of times to carry out the activities of the FEDERATION OF RESIDENTS WELFARE ASSOCIATIONS OF NAJAFGARH and such meetings shall be called with a two day's notice to the executive members mentioning the day, time or venue of the meeting, ordinarily meeting shall be held at the Registered Office or Head Office of the FEDERATION OF RESIDENTS WELFARE ASSOCIATIONS OF NAJAFGARH unless a contrary notice is served upon the members.
- d. Four Seventh of the total number of the Governing Body shall form the quorum of the meetings.
- e. The meeting shall be adjourned to the same day and same time in the next week if no quorum is present within half an hour after the time appointed for the original meeting.
- f. A special meeting of the Governing body shall be called at the requisition of atleast four member by giving three days notice stating clearly the purpose and urgency of calling such special meeting and if within an hour of the time appointed for the meeting no quorum is present, the meeting shall stands cancelled. All the four members who submit the requisition for special meeting will essentially be present to constitute the quorum for conduction the meeting. A special meeting of the Governing Body shall be called at any time of transact urgent business only.

4. DUTIES AND POWERS OF THE GOVERNING BODY.

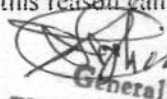
THE GOVERNING BODY SHALL HAVE POWERS TO:

- A Co-opt more than three members to fill the vacancies in the Governing Body.
- B Co-opt four members to Governing Body initially to elect members, if necessary.
- C Cause the FEDERATION OF RESIDENTS WELFARE ASSOCIATIONS OF NAJAFGARH to open Bank Account.
- D Appoint staff on remuneration, determine their privileges like leave, TA, DA and other allowances.

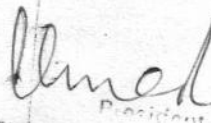

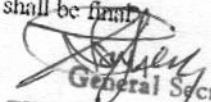

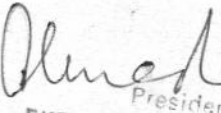
7. GENERAL BODY

- A. The General Body of the FEDERATION OF RESIDENTS WELFARE ASSOCIATIONS OF NAJAFGARH is supreme in the structure of the FEDERATION OF RESIDENTS WELFARE ASSOCIATIONS OF NAJAFGARH.

- E. If no quorum is present with an of the time appointed for the meeting shall stand adjourning any date within a week to which no fresh notice is necessary. In other cases where the meeting is to be held after a week's time fresh notice is necessary to be served.
- F. The General Body Meeting shall ordinarily be held once in a year. In case of more than one meeting. The business relating to appointment of officer/members to the Governing Body shall not be only once in a year.
- G. All acts of the General Body Meeting in the best interest of the FEDERATION OF RESIDENTS WELFARE ASSOCIATIONS OF NAJAFGARH, is final.

8. AUDIT OF ACCOUNT AND UTILISATION OF FUNS

The Society/Federation shall get its account audited once a year by a duly qualified auditor and shall get the balance sheet prepared by him. The auditor should submit a report showing the exact state of financial affairs of the Society/Federation. The Treasurer shall maintain all the accounts and records of balance sheet and audit report.

The funds shall be utilized only in furtherance of the aims and objectives of the Societies and no dividend or benefit shall be taken by any member of the

The mode of election will be by secret ballot.

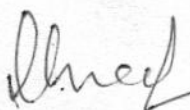
