3. A few observations ( Copy enclosed) were raised by the U.C.Cell. After ractification of those observations Eligibility Slip was issued to ws.While issuing the Eligibility Slip, F.No. 1-33/UC/UD/Policy / 08/PF/ Dt. 11-08- 2008 ( Copy enclosed ), despite our repeated request, the name of the colony and blocks A , B, C , D , D-1,& D-1 Extr., which have been mentioned in the receipt No. 235 Dt. 15-12-07 have not been mentioned by Shri Anil Kumar Singh, dealing Asstt. This has deliberately been done by the dealing Asstt. to harass us and told us to come on 14th August, 2008. Accordingly, we went there on 14th August, 2008 to get the name of the colony and blocks incorporated in the Eligibility Slip. This was done with the indulgence of Deputy Secy ( U.C.). In this connection, photocopy of our letter dated 14-08-08 addressed to Dy. Secy ( U.C.) is enclosed. Name of colony and blocks i.e. A, B, C, D, D-1,& D-1 Extr. were mentioned by Shri Anil Kumar Singh, dealing Asstt on the same Eligibility Slip (photocopy enclosed ) authenticating with his initials.

 While issuing the provisional certificate of regularisation No.F-33/UC/ UD / 2004/ Pt - III dt. 17-09-2008 (copy enclosed) only four blocks i.e. A, B, C & D have been mentioned. Two blocks i.e. D-1 & D-1 Extn. have been omitted.

We have been requesting them time and again to get the above blocks incorporated but of no avail. In this regard, copy of our letters dt.13-10-08, 17-10-08, 18-11-08 & 23-12-08 addressed to the Hon'ble Chief Minister, Govt. of N.C.T. are enclosed for your kind persual.

In view of the foregoing the U.C. cell may kindly be directed to incorporate the two omitted blocks i.e. D-1 & D-1 Extn. in our Provisional Certificate.







Sir:

Kindly refer to our letter dated 13-10-2008(Copy enclosed).

On 6th Oct' 2008 (Monday), we went to U.C.CELL to get the correction made in our provisional certificate. To our utter surprise the concerned staff was not available to get the amendment done and we were advised to see the chief town planner (Sh. Bharti) in this regard, when we went to his office, he was reluctant to see us and after for of persuasion he came out of the room and told all of us (people from various colonies) to come after Wednesday i.e. 8th Oct' 08. Therefore, keeping in view the holidays, we went to U.C.Cell on 13-10-08 (Monday) to get the needful done. There we met the dealing hand Sh.. Anil Kumar Singh, who told us that it is very difficult to get this job done and advised us to meet him after-wards and gave his telephone number: 9212920910 to us. He took us to a corner and said that we will have to pay 2 to 3 thousand rupees for this job. We pleaded him to do our job, but he left his seat around 12:30pm and he did not turn-up till 3:pm. while leaving his seat he again told us to pay the amount and get the job done. 

- A few observations ( Copy enclosed) were raised by the U.C.Cell. After ractification of those observations Eiigibility Slip was issued to w.s.While issuing the Eligibility Slip. 





#### Decision

Briefly stated, Joint Progressive Society, Mansa Ram Park, Uttam Nagar, Delhi submitted documents in the Unauthorized Cell of Urban Development Department for regularization of their colony. A Provisional Regularization Certificate in respect of A,B,C, & D Block of the said colony was issued on 17.9.2008. The claim of the Joint Progressive Society is that they applied and filed documents for six Blocks which were duly acknowledged and eligibility slips was issued but the Blocks D-I, D-I(Extn.) were left out in the Provisional Registration Certificate issued despite of repeated requests and clarifying all the observations made. In this regard Sh. Jage Ram, President of the Society filed an RTI application on 6.3.2009 requesting the information on the following six points:

- (i) Despite of the numerous requests why Provisional Certificate has not been amended/new one issued by Sh. H.K. Bharti, Chief Town Planner and Sh. Anil Kumar Singh, Dealing Assistant whereas all the observations raised by the Urban Development Department were rectified before issue of eligibility slip.
- (ii) Why no action has been taken against Sh. Anil Kumar Singh, Dealing. Assistant who demanded bribe and intentionally omitted two Blocks D-L, D-I (Extn.) in the Provisional Certificate.
- (iii) How many colonies submitted/not submitted the documents and the cases rejected, the number of correct/incorrect acknowledgement slips issued and the number of correct/incorrect Provisional Certificates. The number of Provisional Certificates amended/rectified/corrected and how many certificates not yet rectified.
- (iv) Action against the concerned officials who issued the incorrect certificates and harassed the public.
- (v) Why no action has been taken by Sh. H.K. Bharti, Chief Town Planner against Sh. Anil Kumar Singh, Dealing Assistant. Action taken be intimated.
- (vi) Why superfluous and uncalled observations were raised without scrutinizing the documents meticulously.

The PIO vide his letter dated 9.3.2009 requested the Dy. Secretary (Unauthorized Colonies Cell) of the Urban Development Department to make available the information under section 5(4) of the RTI Act, 2005. The information prepared by Sh. J.G. Arora, Dy. Secretary (UC) as made available was passed on to the appellant by the PIO vide letter dated 17.4.2009 which was stated to be reached on 25.4.2009 to the appellant and reply is reproduced as below:

"5(i) As per the applications submitted in 2007-08 against Regd. No. 993 and 789 separately there are two lay out plans, namely, i.e. for Mansa Ram Park, Block C, D & D-I and ofr Mansa Rasm park Block A & B. In this regard some representations were received for issue / rectification of Provisional Registration Certificates to this Deptt. Matter is under examination. Scrutiny by the MCD/DDA and Revenue Deptt. is also being conducted, Depuisional Regularization Certificate will be issued after the verification of the case.

In the meantime the appellant filed appeal on 20.4.2009 on the ground of not getting the information within the prescribed period.

The appeal was fixed for hearing on 30.4.2009. The appellant having not satisfied with the information given, stated to be received on 25.4.2009, filed written objections on the reply given on the date of hearing i.e. 30.4.2009. The copy of the said objections was given to Sh. J.G. Arora, Dy. Secretary (UC) for filing the counter reply within one week and the hearing was adjourned to 13.5.2009. As no counter reply was filed till 13.5.2009, the hearing was adjourned to 14.5.2009. But again no counter reply was filed and Sh. J.G. Arora, Dy. Secretary (UC) who was present alongwith ATP (UC) was asked to file the counter reply by 15.5.2009. The said counter reply has not been filed, as promised.

After hearing both the parties and going through the contents of appear and the written objections filed by the appellant, the information sent to the appellant by the PIO vide letter dated 17.4.2009 found to be incomplete unsatisfactory, evasive and not relevant to points of the application as is amply clear from the points of information made by the appellant and their replies given by DS (UC) as mentioned above. As per section 19(6) of the RTI Act, 2005 the appeal filed in normal course required to be disposed off within 30 days of the receipt of the appeal. Resultantly only one day is left for deciding the appeal within the prescribed period and the input from Dy. Secretary (UC) is still awaited. In the circumstances, I am inclined to dispose off the appeal with the directions to Sh. J.G. Arora, Dy. Secretary (UC) to prepare and provide point-wise clear, complete and relevant information and the same will be passed on to the appellant by the PIO within 15 days of the date of this order. Before sending the information to the appellant, PIO shall see to it that the information to be provided is clear, relevant and complete in all respects as intended by the appellant in his RTI application.



8(1)(i) The matter regarding inclusion of Block D-I in the Provisional Regularization Certificate is under active consideration and decision thereon would be communicated.

8(1)(ii) In response to this complaint, an explanation of Mr. Anil Kumar Singh has been taken in which he has denied that any bribe was demanded. The work of verification of eligibility slip and issuance of Provisional Regularization Certificate was done in a very short period of 4-5 days and the omission of blocks on the Provisional Regularization Certificate

not malifide/intentional. It has happened inadvertently due to shortage

of time in which proper document could not be examined.

- (b) The Unauthorized Colony Cell has issued 1360 Eligibility Slips on the basis of documents submitted. Since, there was no sufficient time for thorough examination of large No. of applications in the camp, the Unauthorized Colony Cell made all efforts and care to issue the correct eligibility slip. No case of rectification on the eligibility slip was received at that time.
- (c) No document of any Residents Welfare Association has been rejected. However, 421 applications for issuance of Provisional Regularization Certificates are still pending which are under scrutiny/examinations.
- (d) 1360 eligilibility slips were issued in a very short period of 4-5 days and Unauthorized Colony Cell has made its best efforts to issue the correct eligibility slip. However, omission/correction, if any, was made at that time on the request of Residents Welfare Associations, and production of sufficient proof of such correction.
- (e) Unauthorized Colony Cell has tried its best to issue all the 1218 Provisional Regularization Certificates correctly in the limited period of 4-5 dyas after summary examination of the submitted documents. Correction required, if any, in the Provisional Regularization Certificate will be made by the Unauthorized Colony Cell after the new certificates are got printed and received in the name of new Urban Development Minister, Delhi.
- (f) No Provisional Regularization Certificate has been amended till date, as the new certificates have not been got printed so far.

The Provisional Regularization Certificates have been prepared in the limited period of 4-5 days before the Assembly Election, 2008 when it was not possible toexamine all the documents submitted by 1639 Unauthorized Colonies. Best efforts were made to issue all the Provisional Regularization Certificates. However, if any, inadvertent mistake has happened, it will be rectified after the new certificate are



statement on record that they have not got enough time to scruitnise the files,

before issue of eligibility slips. Their contention that they got only 4 to 5 days is baseless, illogical and wrong in all respects. It is a white lie. They got more than seven months. 





Department ( UC Cell). Whereas, all the observations raised by U.D. Department ( UC Cell) were rectified before issue of eligibility slip No. F No. 1-33/ UC / UD / Policy / 08/ PF / dt. 11-08-08, as evident from the enclosures attached with our letter dt. 28th February, 2009 mentioned above.
- b.) Why no action has been taken against Sh. Anil Kumar Singh, dealing Assistant for demanding bribe from us. It is amply clear from the eligibilty slip, where he had omitted colony name and all the blocks intentionally which were got incorporated with the indulgence of Dy. Secy. U.C. cell on 14th August, 2008. Both the eligibility slips original and amended may kindly be perused, as enclosed with our letter dt. 28th February 2009. Further Sh. Anil Kumar Singh, had intentionally omitted two blocks i.e D-1 & D-1 Extn. in the provisional certificate. After perusal of these slips and provisional certificate, no more documentary proof should be necessary to prove malafied intention of Sh. Anil Kumar Singh, dealing Assit.


