With reference to your application on the subject cited above. - That the adequate sports material shall be purchased for out door and indoor games during the year 97-98.
- That the school shall strictly abide by the provisions of Delhi School Education Act and Rules, 1973 and payment shall be made as per section 10 (I) of Delhi School Education Act, 1973 to all the employees through crossed cheque and proof shall be shown to concerned E.O.
- That the enrolment in each section shall not exceed the number of students calculated 0 12 ft. per student for the available floor area of the class room and the school
