
With reference to your application on the subject cited above, I am directed to convey the approval of the Director of Education, Delhi to grant recognition to your school from classes 1st to VIII (without aid) w.e.f. academic session 1997-98 subject to the fulfillment of the following terms and conditions:

1. That the school shall abide by the provisions of Delhi School Education Act and Rules, 1973 framed thereunder as well as the instructions issued from time to time.
2. That the school shall admit students without any discrimination of caste and creed and preference shall be given to the students of the area concerned.
3. That the school shall appoint more full time qualified and eligible staff for all the classes of the school as per the present norms of the department and the proof should be provided to the E.O. for verification.
4. That the school shall equip the Science Lab. as per the norms of the department and suitable facilities for practical work shall be provided to the students. More material worth Rs. 5000/- shall be purchased during 1997-98 and a list be furnished to the Education Officer for verification.
5. That a proper Library shall be established and facilities for reading room shall also be made available for students as well as teachers. More approved standard books shall be purchased. Books as per the ratio of 10 books per student may be added and facilities of reading room may also be provided immediately and more books worth Rs. 5000/- be purchased by the start of next session and the list of books are furnished to E.O. for verification.
6. That the adequate sports material shall be purchased for out door and indoor games during the year 97-98.
7. That the school shall strictly abide by the provisions of Delhi School Education Act and Rules, 1973 and payment shall be made as per section 10 (I) of Delhi School Education Act, 1973 to all the employees through crossed cheque and proof shall be shown to concerned E.O.
8. That the enrolment in each section shall not exceed the number of students calculated @ 12 ft. per student for the available floor area of the class room and the school

shall provide adequate and sufficient accommodation per the norms of the department in each class. The number of existing section should not exceed the number of class room of proper size in the school.

9. That the school shall not run any pre-primary and unrecognised classes shall be run at one place. Nursery classes be removed from the premises of the school, if any. No branch of this school shall be run under the banner of the recognised school.
10. That the school shall dispense with the services of unqualified and overaged staff, if any, immediately.
11. That all the facilities prescribed under Rules 50 and 51 of the DSER, 73 shall be made available to the students, provisions of Rules 6,7 and 9 be strictly observed.
12. That the service contract between the management and the employees shall be executed immediately.
13. That the arrangement of good drinking water shall be made available to all the students as well as to the teachers and sanitary facilities shall also be provided to the students adequately.
14. That the violation of any instructions/orders/conditions/rules and regulations of department shall lead to the withdrawal of recognition of the school and class-IX shall not be opened without the prior approval of the Director of Education, Delhi.
15. That the Management of the school shall provide all the facilities as per rule 50 and all conditions as required under rule 51 shall be complied with.
6. That a report about the fulfilment of the above conditions giving the extent to which each conditions is fulfilled shall be sent to the Education Officer every six month.

11. That the society shall apply for land to DDA for establishing schools as per laid down norms.
12. That the school shall enroll students in each section such that each student gets 10 sq. feet space of the room.

8. The school shall maintain section teacher ratio at least 1:1.5 at each level i.e. Primary (I-V) Secondary (VI-X) and Sr. Secondary (XI-XII).

MEMBERSHIP:-

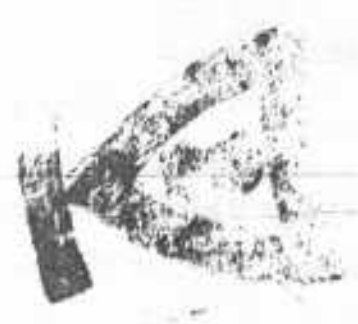

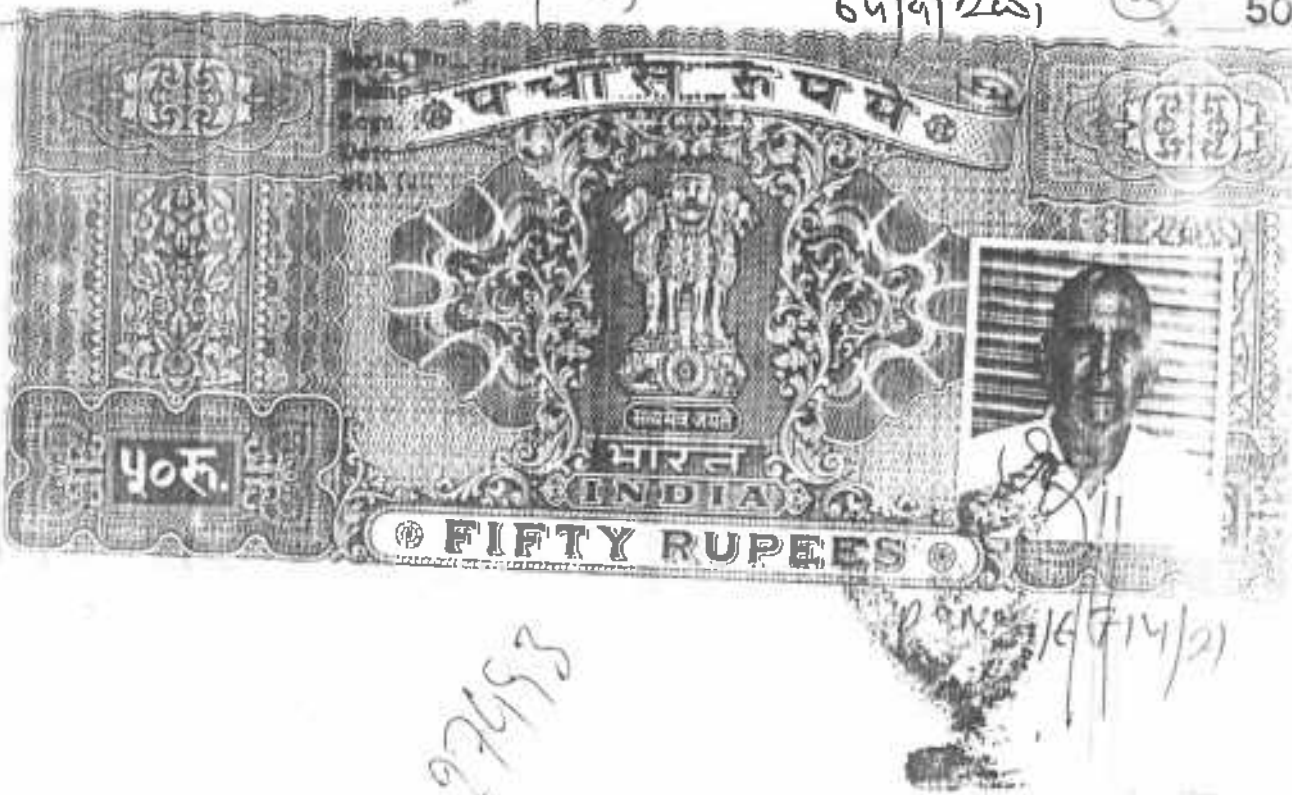
