जिन्दपुर गाँव दिल्ली का एक ग्रामीण गाँव है। जिन्दपुर गाँव की विस्तार आबादी मानवित्र में दर्शाये गये प्लॉट गाँव के पुराने मूल निवासियों के ही हैं। ये प्लॉट उनकी अपनी स्वंय की जमीन या खरीदी गई जमीन पर ही स्थित हैं जो लाल होरे से जुड़े हुए हैं। सन् 1908 में जिन्दपुर गाँव का पुराना लाल होरा तय हुआ था। इसके पश्चात् सन् 1952-53 में गाँव की चकबंदी हुई थी। तब से अब तक गाँव की आबादी लगभग 8 गुणा बढ़ चुकी है। लेकिन न तो गाँव की दुबारा चकबंदी हुई है और न ही लाल होरा बढ़ा है। आवास की जमीन कम होने के कारण ग्रामवासियों ने अपनी स्वयं की खेती की भूमि में ही रहना तथा अपने पशु बाँधने शुरू कर दिये हैं। ऐसा लगभग 15-20 वर्षों से हो रहा है। अतः गाँव की आवास की समस्या को देखते हुए, गाँव के लाल होरे के बाहर आबाद इस बस्ती को गाँव के रूप में ही बढ़े हुए स्वरूप में नियमित किया जाये। यह भूमि न तो अधिग्रहण अथवा ही.ही.ए. व किसी भी प्रकार के सरकारी प्रयोग में नहीं है।


