


The petitioner contends that they are possession of the land for the last more than 50 years and a house was constructed much earlier than 28th October, 1956. It is submitted that in view of the provisions of Section 7(1)(b) of the Deihi Land Reforms Act, the land, on which the house had been constructed as on 28th October, 1956, could not vest in the gaon sabha. It is submitted that the Gaon Sabha had in fact filed a suit under Section 84 of the Delhi Land Reforms Act against the petitioners for their dispossession from the said land, however, the said suit was dismissed Ly the Assistant Collector (Grade-I) by his order dated 31st July, 1961. It is submitted that the order of the Assistant' Collector (Grade-1) having become final, the respondent could not treat the land, on which the petitioners have constructed their houses, as the garn sabha land and they could not be dispossessed therefrom.


forefathers. The loss of the documents produced by the gaon sabha has given a chance to the appellant to prefer this appeal on the pretext that the gaon abha has nothing to establish its title. Without going further into the merits of this case, I feel that it is a fit case to be remanded to the trial court with the directions that the gaon sabha should be directed to produce certified copies of the documents which it had filed initially and ultimately lost in transit.

With these observations, I hereby set aside the order dated 9.7.1971 passed by the lower court and remand the case back to it with the directions that the gaon sabha should be asked to produce on record the certified copies of the documents which it had initially filed. The appellant should also be given opportunity for the production of any document in support of his contention. Both the parties are directed to appear in the lower court on 2,1-11-72 At 10. A.M. Pronounced.

were some-how lost in transit when the case was transferred. He had further mentioned that departmental proceedings against the officials concerned were instituted. Thereafter the gaon sabha was directed to lead further afresh evidence but the same was not produced by it. The lower court nowever found on record the khasra girdawari dated 24.9.1968 in which khasra number 1890 was shown to have been recorded as the property of the mon sabha. The lower court however gave its verdict on this particular extract of khasra girdawari. It is not mentioned in the lower court order that for which period this entry relates to. The lower court has mainly relied upon this entry and ordered the ejectment of the appellant/respondent from khasra number 1690. As regards other khasra number i.e. 1692 the lower court findings are in favour of the appellant and nothing about this khasra number has been agitated in appeal. Now the question before me is to decide whether there is any encroachment on this khasra number or not. As the recorded produced in evidence by the gaon sabha is stated to have been lost the alternative would have been to produce afresh documents. Since this has not been done, it is difficult to sustain the lower court finding. It is true that the appellant/respondent has not produced any documentary evidence to show that he is in any way entitled to retain possession over this area but in support of his contention he has examined as many as seven witnesses including himself who stated that the land in dispute is in the continued possession of the appellant/respondent since the time of his

had always been in actual, physical, continuous and lawful possession of the appellant/respondent and his forefathers and his house had been built on it some 60 years ago.

After the parties had finished their evidence, the lower court after evaluating the evidence came to the conclusion what the respondent had failed to prove his title over the disputed land and ordered the ejectment of the appellant/respondent from khasra number 1690. With regard to khasra number 1692, he held that the gaon sabha had failed to prove its ownership. Aggrieved by the order of the revenue assistant, the present appeal has been preferred by Prem Raj appellant.

assistant on the ground that the trial court has erred in ignoring the fact that the land in question was in the vicinity and surrounding of the abadi site and the same was being used by the appellant since times immemorial for residential purposes since the time of his forefathers. That the trial court has not properly appreciated the evidence on record and there was no evidence led by the gaon sabha to establish that the encroachment was of recent origin. That the lower court has erred in holding that the appellant was liable to ejectment from khasra number 1690.

I have heard the counsel for the parties, perused the file of the lower court and the impugned order. 

### ORDER

This is an appeal against the order dated 9.7.71 passed-by Shri A.G. Cutting, Revenue Assistant, New Delhi in proceedings under-section 86(a) of the Delhi Land Reforms Act instituted by the gaon sabha of village Aaya Nagar against the appellant Prem Raj. The brief facts of the case are that the secretary, gaon sabha Aya Nagar instituted proceedings under-section 96(a) of the Delhi Land Reforms Act for the ejectment of Prem Raj appellant from the land bearing khasra numbers 1960(1-0) and 1962(2-15) situated within the revenue estate of village Aaya Nagar on the ground that the appellant/respondent inspite of repeated reminders did not vacate the possession over khasra numbers as mentioned above which was the gaon sabha property. On receipt of this information the learned lower court issued notice to the respondent/appellant to show-cause why he should not be ejected from the plots mentioned above. In reply to the actice the appellant/respondent filed his objection stating that the provisions of section 86(a) of the Delhi Land Reforms (Amendment) Act, 1965 are not applicable to the abadi land of private holdings and that the application of the gaon sabha was vague and did not give the necessary details about the alleged encroachment and that the contents of the application of the gaon sabha were false and that the land in dispute contd...2.


