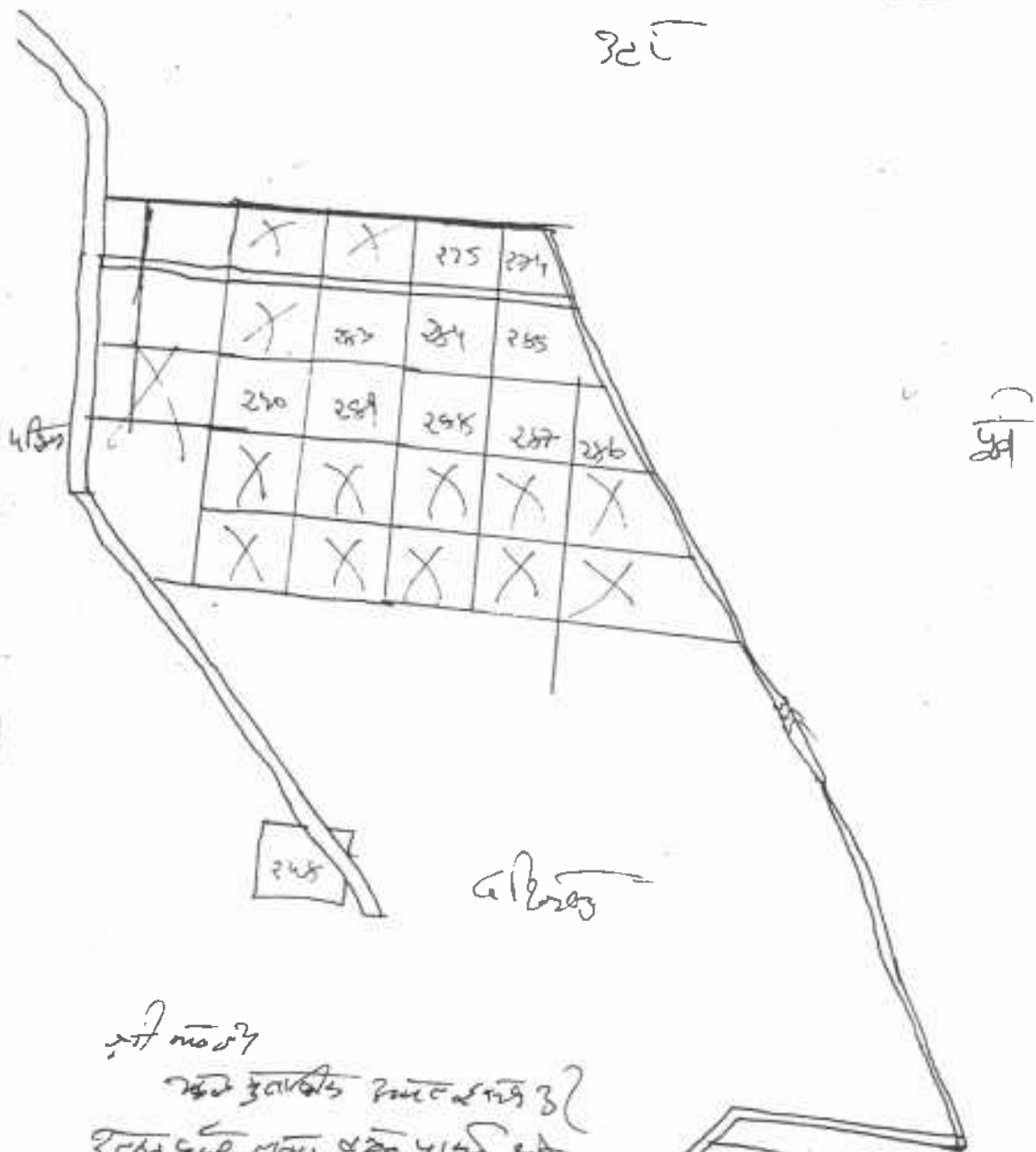

The election of the Governing Body members and office bearers shall held after every 5 years in General Body Meeting. ~~xxxxxx~~ The list of names, addresses, occupations & designations of elected persons shall be sent every year to the office of Registrar of Societies, Delhi, as per provisions of Sec. 4 of S.R. 15. MODE OF ELECTION:--

If any of the members or office bearers of the society resigns, then the same shall be put before Governing Body Meeting, and its decision shall be final.

12. VACANCY :--

Any vacancy caused due to any reason shall be filled by the Governing Body but its approval shall be done by the General Body.

13. QUORUM :--

The quorum of the General Body and Governing Body Meetings shall be 1/3rd presence of total strength, failing which meeting shall be adjourned for some other date & no quorum shall be required in such adjourned meeting, as aforesaid.
