



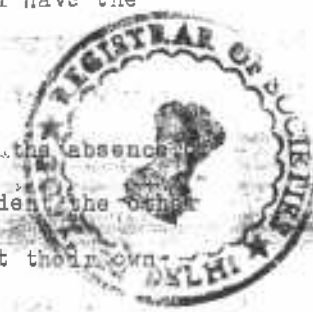

(vi) "Secretary" means the Secretary of the Association.



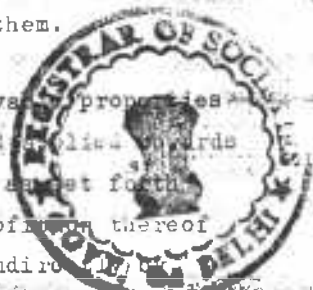

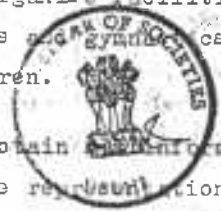
