It is pertinent to mention here that out of total land relating to village Basai Dara Pur notified for acquisition vide general notification in the year 1959 an ex-parte award for 77 bighas and 8 biswas was made in the year 1997. That in the said award it is clearly stated that, as the whole area is fully built up, the possession of the awarded land can not be taken. That this fact has been further confirmed by letters of Directors (LM) DDA And SDM Patel Nagar dated 30.9.99 and 18.2.2000 respectively (Copy enclosed).

It is worthwhile to mention here again that villagers/habitants have never taken any compensation in respect of the awarded land till date.

That out of 77 bighas and 8 biswas demolition proceedings were carried out by DDA in the year 2002. That as claimed by DDA possession of 58 bighas Appx. was taken only on paper. That this claim of DDA is completely false and incorrect. The fact is that the physical possession of the said land is with the habitant/owners till date.

That it is also pertinent to mention hereby that out of 77 bighas and 8 biswa some other RWA of village Basai Dara Pur, has also applied for regularization for their Respective land measuring about 10 Bighas separately which falls under the same Khasra No.i.e. 732, 733, 734 of extended village abadi.

That a bifurcation of the total land measuring 77 bighas 8 biswas is as follows for your kind perusal:-

It is submitted that we have applied for regularization of the extended abadi of Village Basai Dara Pur, New Delhi on 20<sup>th</sup> March 2008 vide receipt No.08 in response to the application invited by Urban Development Deptt. of Delh Govt. or regularization of unauthorized colonies and which also covers the extended abadi of the village under the head 3.2 i.e. habitation eligible for regularization.

In this connection, you would kindly recall about the meeting held on 30<sup>th</sup> May, 2008 in your office in which Sh. Ajay Maken, Hon'ble Minister of State for Urban Development, Sh. Sajjan Kumar, MP and Sh. Mala Ram Gangwal, MLA along the representatives of village Basai Dara Pur were present and submitted representation for regularization of Khasra no. 732,733,734 of extended abadi of village Basai Dara Pur, Vice Chairman of DDA including senior officers of DDA, U & D Deptt. Delhi Govt. were also present in the meeting.

That after hearing and due deliberation, your goodself directed the villagers to file affidavits regarding their ownership, total area and affirmation that they have never received any compensation in respect of the above said land. **Regularisation of the extended Abadi of village Basai  
Darapur, New Delhi-110015**

In continuation of my D.O. letter dated 26<sup>th</sup> November, 2007, please find enclosed letter from Sh. Mala Ram Gangwal, MLA alongwith representation together with its enclosures from Basai Jan Kalyan Samiti (Regd.), WZ-104, Basai Darapur, New Delhi-110015 regarding their request for regularization of built-up houses forming part of Khasra No.732, 733 & 734 in the village Basai Darapur in the extended Abadi due to natural growth of the population over the years. In this connection, I draw your kind attention to the notification dated 24<sup>th</sup> March, 2008 issued by DDA relating to regulations for regularization of unauthorized colonies of Delhi which inter-alia covers the extended abadi of the villages under the head 3.2 i.e. habitations eligible for regularization. The RWA of the village also applied for its regularization vide receipt No.08 dated 20<sup>th</sup> March, 2008 in response to the applications invited by Urban Development Deptt. of Delhi Govt. for the purpose.

Out of the total land measuring 77 bighas and 8 biswas notified for acquisition in the village in the year 1959, the DDA required only 10 bighas and 13 biswas as could be seen from the enclosed letter dated 30<sup>th</sup> September, 1999 from Director (LM) to the aggrieved persons of the village. However, the land owners have not taken the compensation even in respect of 10 bighas and 13 biswas deposited by DDA in the treasury and the physical possession of the land is also with the land owners though on paper DDA claimed to have taken over its possession. As such, it has been defined as a private land as per the notification issued by Delhi Govt. in this regard. Despite the fact that the remaining land was not required by DDA, the same has not been denotified so far despite the lapse of so many years. The extended Abadi of the village Basai Darapur is on private land and not on Govt. land and has been in existence since decades.

In this connection, you would kindly recall that the undersigned alongwith a delegation of prominent representatives of village Basai Darapur met your goodself on 27<sup>th</sup> November, 2007 and submitted representation for denotification of Khasra No.732, 733 and 734 of the extended abadi of village Basai Darapur, senior Officers of DDA including Commissioner of Land (L&M) were also present in the meeting. After hearing, your goodself directed the Commissioner (Land) to ascertain the status of the land prior to its demolition in January, 2002 and the villagers were directed to submit their proof in this regard. Accordingly, they met the Commissioner Land and

Your goodself may kindly recall that a meeting was held in your esteemed office on 30<sup>th</sup> May, 2008 in which Sh. Ajay Maken, Hon'ble Minister of State for Urban Development, Hon'ble Sh. Sajjan Kumar, MP alongwith representatives of village Basai Darapur, senior officials of DDA and Urban Development Deptt., NCT of Delhi were present. You were handed over letters from Sh. Sajjan Kumar and the undersigned explaining that the villagers have not taken any compensation of their land and physical possession is also with them. Though DDA claimed to have taken possession on paper. According to the clarificatory notification issued by Delhi Govt. dated 12<sup>th</sup> December, 2007 (copy enclosed), the extended Abadi of village Basai Darapur is on private land and not on Govt. land and has been in existence being ancestral properties since hundred of years. The RWA of the village also applied for its regularization vide receipt No.08 dated 20<sup>th</sup> March, 2008 in response to the applications invited by Urban Development Deptt. of Delhi Govt. for the purpose.

After sympathetic consideration, you had kindly directed the villagers to file their affidavits to the effect of their being owners and in possession of their land as well as have not taken its compensation from the Govt./DDA, etc. Accordingly, they are enclosing their Affidavits, Site Map and letters from Director, L&M, DDA and SDM, Patel Nagar dated 30<sup>th</sup> September, 1999 and 18<sup>th</sup> February, 2000 respectively clearly indicating that their land was heavily/thickly built-up.

I, therefore, request you to kindly exercise your good offices for issuing necessary instructions to the concerned officials:-

1. To regularize the extended Abadi of the village Basai Darapur and
2.
