



demarcate MCD plot No.216 hearing Khasra No.115 measuring 4 Bighas and 7 Biswas as against the Khasra No.125. The second application CM No.6054 of 2005 was also filed for impleadment as party respondents. The entire case of the applicants was that they had purchased the land which falls in Khasra No.115 of MCD Plot No.216 pursuant to auction conducted by the Hon'ble High Court and the same do not form part of Khasra No.125 and it required to be segregated. The matter was heard from time to time by the Hon'ble High Court and notice for demolition was also kept in abeyance pursuant to our petition and argument at length. In the meanwhile, our application was also allowed for demarcation and the Revenue Authorities gave a favourable demarcation report on 14/15.5.05. Thereafter, again a prayer was made for the second fime for demarcation and the second report dated 8/9.7.05 was against. The fact remains that the second report was erroneous since the point taken for measurement and demarcation was incorrect.

Accordingly, a detalled objection was filed before the Hon'ble High Court which is yet to be decided wherein it was also prayed for fresh demarcation by an independent agency. It is submitted that DDA with the help of the Police removed unauthorized construction and encroachment in Khasra No.125 as per their own admission on 7.3.2005 without touching Khasra No.115 since they had the knowledge that it was private land purchased pursuant to decree and execution followed by certificate to sale by Hon'ble High Court of Delhi of 4 Bighas and 7 Biswas in Khasra No.115 which was never transferred to DDA.


