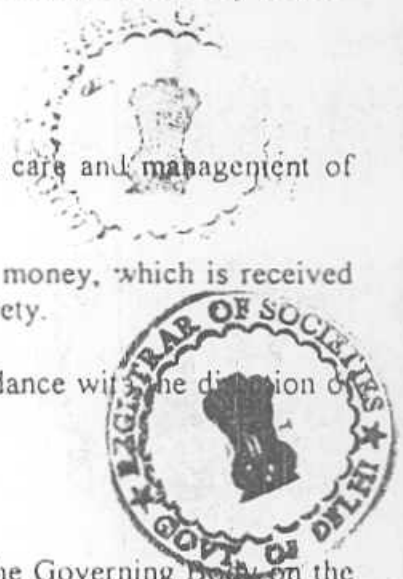

The Governing Body of the society shall have the powers to expel / terminate a member or/ and members, from the membership of the above society, on the following grounds

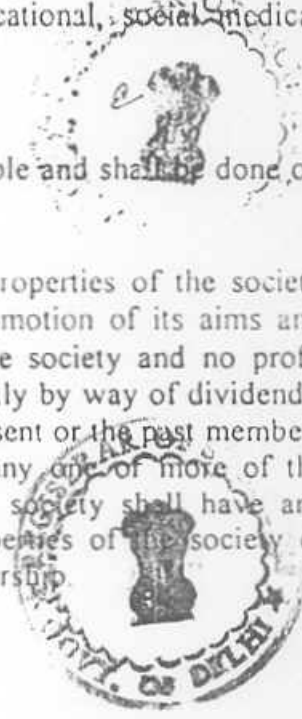
